Without any further consideration from Boo2Bullying (B2B) and its representatives, I hereby grant and assign to B2B the right to utilize my child's appearance and contributions in connection with Desert's Got Talent and any derivative works in any and all media in perpetuity.
  
- II. **Publicity/ Consent:** I agree that my child's appearance in B2B video, photography, and the Desert's Got Talent production and any derivative works may be used and edited by B2B at its sole discretion. I consent to the use of my child's name, likeness, voice, video and photographic image, and biographical material for cable casting, broadcasting, promotional, advertising, and other business-related promotional purposes on behalf of Boo2Bullying. The rights hereby granted to B2B include the perpetual, exclusive and unencumbered right to use, edit, reproduce, distribute, telecast, publish and otherwise exhibit the appearance worldwide, including excerpts, in any and all forms of media and in the advertising and promotion of such use.
  
- III. **Indemnity:** I expressly agree to release, indemnify and hold harmless Boo2Bullying and its affiliates, officers, directors, agents, employees, licensees and assigns from and against any and all liabilities, claims, damages, injuries, costs, and expenses (including attorney's fees) which I or my child may have for invasion of privacy, defamation, right of publicity, personal injury, property damage or any other cause of action arising out of the production, distribution, syndication, or exhibition of B2B video, photography, derivative works or appearances.
  
- IV. **Ownership:** I agree that all rights of every kind, including but not limited to copyrights, as well as any proceeds derived from my participations in Desert's Got Talent shall accrue to Boo2Bullying and its successors, assigns and licensees.
