PREFACE

The importance of the Dog Robber's duties at every level of the Military Order of the Devil Dogs, Inc. (MODD) cannot be overstated. For the MODD to run in an orderly fashion, it is important that each Dog Robber in every Pound and every Pack understand their job and do it accordingly.

It is especially important that holding up transmittals, advancement forms, and other paperwork not occur at the Dog Robber's position. The Dog Robber at every level holds the key to expedite timely returns of membership cards and other pertinent MODD related materials.

The Dog Robber's position is perhaps the most important one in the Order. It must not be taken lightly and one should be sure that they are willing to accept the duties as outlined here, and as defined in the Bylaws and Ritual of the Order.

With a little effort, good records and timely preparation of your duties, this will make life much easier for yourself and the others that process them. Following the outlines of duties, example forms are enclosed for your assistance.

THE DUTIES OF THE POUND DOG ROBBER

General

A separate Checking Account bearing the name of your Pound should be maintained with a reputable FDIC bank or other FDIC financial institution.

- 1. This account should require two (2) signatures on every check.
- 2. It is suggested that three (3) Officers be authorized to sign: Pound Keeper, Sr. Vice Pound Keeper and Pound Dog Robber. Having the third person authorized protects against problems with illness, absence or distance.

The Pound Dog Robber should possess a rubber stamp containing the name of the Pound and an appropriate phrase (such as "for deposit only") to deposit all checks received. If possible, this stamp should include the account number.

All checks for the various Order accounts should be made payable as follows:

- 1. If you have a Pack in your State, all payments should be made out to "(your state name) Pack"
- 2. For all activity with the Kennel Quartermaster, all payments should be made out to the "Kennel Quartermaster".
- 3. For all activity with the Kennel Dog Robber, all payments should be made out to the "Kennel MODD".
- 4. For all other activities, including fund-raisers, information should be presented beforehand for the appropriate payment designee.

All forms are available on the Kennel Web Site at www.moddkennel.com These forms are interactive and may be filled out online. Print as many copies as you need.

Dues, reinstatement fee structures and regulations are as follows:

- 1. The membership year expires 31 August.
- 2. Members not paying their dues by 1 February (the first day of the sixth month, Section 107 A of the Kennel Bylaws) shall be deemed delinquent.
- 3. Should the delinquency extend beyond the last day of the SUPREME GROWL of the KENNEL, the individual shall be dropped from the active rolls for non-payment of dues.
- 4. Members finding themselves in the situation of Dues #3 above will be placed on a Kennel delinquent list for one additional year.
- 5. Such members are not eligible to participate in any activities or wear any Devil Dog insignia until their dues are paid.
- 6. Kennel reinstatement fees are assessed after a Devil Dog has been placed on the delinquent list, and the individual is assessed at \$2.00 per year for a maximum of three years (\$6.00). In addition, Kennel back dues must be paid for up to three years at the current rate along with current dues.
- 7. Packs and Pounds may set additional reinstatement fees.
- 8. Each Pound should make every effort to ensure that dues are collected and transmitted on time in order to allow for a smooth operation, as well as to provide timely processing of degree advancements and transfers.

Transmittals

All transmittals must be processed in a timely fashion. It is very important that the individual Pound Dog Robber send all transmittals immediately upon receipt of dues to the proper office with the appropriate fees for the ensuing levels of the organization (as outlined below):

- 1. Where a Pack exists, the transmittal must be sent to the Pack Dog Robber along with checks made out to the Pack and Kennel that includes the dues (and where applicable the reinstatement fee) amounts for all members listed on the transmittal.
- 2. Where a Pack does not exist, the transmittal must be sent directly to the Kennel Dog Robber along with a check that includes the Kennel dues (and where applicable the reinstatement fee) amounts for all members listed on the transmittal.

All transmittals must be completed in their entirety and must adhere to the following format:

- 1. Each transmittal must have the date prepared in the appropriate space on the upper right corner.
- 2. Enter Transmittal number. Start each membership year (1 July) with transmittal #1 (IE. 001-2017 or 2017-001).
- 3. Complete the top portion in its entirety (from and via). Remember that the "from" is for the Pound Name.
- 4. Members must be listed in alphabetical order as follows: last name; junior/senior; first name; middle initial.
- 5. Do not use nicknames or abbreviations, use only full names, such as listed on the Marine Corps League Membership Roster received from National Headquarters.
- 6. Include the Degree and Dog Tag Number of each member listed, including new Pups. (exception new Pups who have not yet had a number assigned by the Kennel Dog Robber may be left blank).
- 7. Include the member's Marine Corps League Membership Number or, where applicable, the member's Marine Corps League Life membership number.
- 8. Enter date of initiation/birth where applicable. <u>DATE OF BIRTH IS REQUIRED FOR ALL NEW LIFE MEMBERSHIP REQUESTS WHICH IS THE MEMBER'S ACTUAL DATE OF BIRTH.</u>
- 9. Include the member's address, city, state, and zip code (with the +4 designation).
- 10. Complete the bottom portion with the fiscal year being processed, total counts and calculated dues figures for Kennel (and where applicable, for Pack). Print your name, address and Degree. Be sure to leave space for your signature, then sign the document.
- 11. DISTRIBUTION see the bottom of the form for proper distribution; send with the required check(s) through the chain of command.
- 12. All change of addresses should be noted so that the Pack and Kennel Dog Robbers do not overlook them. It is recommended to use the two entry format which the MCL Headquarters uses for COA. Line one: Old Address; Line two: New Address.
- 13. New Life member applications are to be separate from all other transmittal data and on their own transmittal form. Multiple life requests may be submitted on the same transmittal.





- DATE OF BIRTH AND MARINE CORPS LEAGUE PLM NUMBER ARE RE-QUIRED FOR APPLICATIONS FOR LIFE MEMBERSHIP. Please note at the top of these transmittals "Life Memberships".
- 14. New Life membership dues are based on age. See Kennel Bylaws Section 1209 (E) for current prices.

After the Supreme Growl at the National Convention each August and before September 15, a full list of all MODD Life Members in your Pound must be completed and sent to the Pack and Kennel Dog Robbers through the proper channels. This document may or may not be on a transmittal at your discretion. However, if it is not sent on a transmittal form, it should include the following data for each listed member:

- 1. Full Name (Last, Jr./Sr., First, Initial)
- 2. Street Address
- 3. City, State, Zip Code (plus 4)
- 4. Degree
- 5. Dog Tag
- 6. MODD PLM Number
- 7. MCL Life Membership Number

Membership and Advancement Forms

Advancement forms for Pup and Devil Dog must originate with the Pound Dog Robber. This includes advancement to Devil Dog of a member at the Grand Growl of the Pack or at any special growl of the Pack. It is important that the Pound know a member is advancing. It also allows the Pound to control who deserves to advance; it should not be considered an automatic event. Remember, you had to EARN the right to become a DEVIL DOG. Members MUST EARN the right to advance.

- 1. All Dogs requesting advancement must have their membership for the current fiscal year paid in full before initiation.
- 2. As with Transmittals, all information requested with appropriate signatures and dates must be completed.
- 3. All forms should be processed speedily. Delays may deprive a member of their next advancement in Degree at a future Pack Growl, Grand Growl or Supreme Growl.
- 4. The Dog Robber should double check all forms for completeness before forwarding them to the next higher office. Mistakes and omissions are more easily corrected at the Pound level prior to any mailings.
- 5. For all Applicants, fill in the top section entirely (date of application, name, address, city, state, zip (+4)) similar to a dues transmittal.





- 6. FOR NEW PUPS ONLY, use membership application. Please note that the Detachment Commandant's and two (2) dogcatchers' signatures are required. Sir Pound Keeper and Sir Dog Robber must view and attest to applicant's proof of USMC or FMF Chaplain service documents. The applicant's MCL number is required, not their MCL PLM number. Be sure that all signatures and dates are completed.
- 7. For new Pups and for all Degree advancements, the applicant must complete and sign the medical disclaimer section, including the underlined area for physical and mental impairments (if any). It is extremely important that where there is no illness or impairment the applicant must write the word "NONE". Upon completion of the initiation, the jurisdictional Mad Dog and a Witness must also sign this section.
- 8. For advancement to the Degree of Devil Dog: Use the degree advancement application. Be sure to check the appropriate box for the degree the candidate is advancing to, include the applicants Pound number and Dog Tag number, check the appropriate box for the degree the candidate is advancing from, then after dating and signing the form forward to the jurisdictional Pack Dog Robber (or to the Kennel where no Pack exists) for further processing. The Bylaws require a letter of recommendation from the Pound Dog Robber to be attached to the Advancement papers for a Pup to become a Devil Dog.
- 9. FOR NEW PUPS ONLY, enter the date of the Degree. For all others, leave blank.
- 10. Follow the instructions on the bottom of the form; send the remaining copies through the chain of command for acknowledgment and processing.
- 11. Transmittal(s) with the appropriate dues amounts for the ensuing fiscal year for all Pups in process must accompany all forms, as well as in cases of dues payments and reinstatement fees for those advancing to Devil Dog. New Pups being initiated between 1 March and 31 August will be assessed 1/2 Kennel dues. Forms received without the necessary fees and paperwork will be returned.
- 12. For advancements to Pedigree Devil Dog: See Pack Dog Robber section.

Requests for Transfer

Any member requesting a transfer must use the Request for Transfer form available from the Kennel Headquarters.

- The individual requesting transfer should fill the top section in its entirety. Use "N/A" in places that are not applicable. Section I must be completed, signed, and dated by the transferring member. This form should then be mailed to the Pound Dog Robber of the losing Pound.
- 2. Section II must be completed, signed, and dated by the losing Pound Keeper and Pound Dog Robber. Please be sure to check off and fill in all of the appropriate parts. If the individual is indebted or disapproved, please explain why.
 - a. For an approved transfer, the forms should be mailed to the Pound Dog Robber of the gaining Pound.
 - b. For a disapproved transfer, the form should be returned to the requester.
- 3. Section III must be completed and signed by the gaining Pound Keeper and Pound Dog Robber. It should be noted that the gaining Pound has the right to vote on the acceptance or denial of this transfer.





- a. Where a denial has been made, please explain why and return the form to the losing Pound Dog Robber. After making a copy for the Pound's records, the Pound Dog Robber should return the form to the requester.
- b. Where an acceptance has been made, follow the directions on the bottom of the form as to disposition and copies. Remember that the copy that goes to Kennel Dog Robber (through Pack Dog Robber as applicable) needs to be accompanied by a properly completed transmittal listing the transferring member.

Pound Officer Installation Reports

Immediately after the election of Pound Officers, the Dog Robber should complete the Officer Installation Form in its entirety, including the Degree and Dog Tag number for every Officer listed. Be sure to complete all of the required information. Section 209 of the Bylaws outlines the Offices that must be elected. The Offices that are required for Pounds with minimal membership are found in the Bylaws Article II Section 209 E.

Upon completion of the Installation, the Dog Robber should have the Installing Officer sign the form. The Dog Robber should then detach the bottom copy and forward all others to the Pack Dog Robber. Where no Pack exists forward all copies to Kennel Dog Robber. A copy should be made available for the Pound Keeper for their records. The Dog Robber for future reference should keep one copy of the report on hand at all Growls of the Pound.

Remember that the Pound Keeper must have the Degree of Pedigreed Devil Dog (preferred) or Devil Dog. Pups can only hold an appointed or elected Office, after having their Degree for at least one full calendar year (with the exception of application for a Pound Charter).

Death Notices

As soon as possible after being informed of the death of a Member, the Dog Trainer (with the assistance of the Dog Robber) should complete the Notice of Death form. A copy of the Notice of Death should be made for the Dog Robber's records. Forward immediately the copies as noted on the bottom of the form to the appropriate Officers (Pack Dog Trainer, Kennel Dog Trainer and Kennel Dog Robber) and Pack Dog Robber or, where there is no Pack, forward the Death Notice to the Kennel Dog Robber.

Incorporation

Each Pound must obtain an EIN number from the Internal Revenue Service and then obtain incorporation as a non-profit organization in their state. In order to protect your members from possible legal action, each Pound and Pack must be incorporated as a non-profit. This is generally handled through the Secretary of State office. Each state differs somewhat in their exact requirements. When you become incorporated send the date of incorporation to the Kennel Dog Robber.





Federal Taxes

Each Pound must file taxes annually just as an individual must. Send your EIN number to the Kennel Dog Robber. That office will forward the number and your other information to the MCL headquarters. They will request the IRS to include your Pound on the list of subsidiary organizations of the MCL. Once that is accomplished you will be able to file a 990N tax postcard annually. If you do not follow these steps you will have to Request a separate determination from the IRS to find you are a non-profit and then file a 990EZ annually. Report your successful filings to the Kennel Dog Robber.

IRS Requirements

The IRS requires non-profits to file taxes each year just as you must for yourself. In order to do this, you must have an EIN number. To get one, simply go on line to <u>us-tax-id-number.com</u> and apply as a non-profit. Once you have an EIN let the Kennel Dog Robber know and it will be sent to the MCL for inclusion on their list of subsidiaries. Patience is required. It takes a while to get the list to the IRS and for them to respond.

Next, when you have been accepted by the IRS, go to https://sa.www4.irs.gov/epostcard/ Follow the instructions to either become a first time user or log in as a returning user and complete filling out the form. Enter the Marine Corps League as the parent organization and your Pound Name on the DBA line on the next page. When the IRS accepts your filing send the information to the Kennel Dog Robber.

Other Duties

Keep the Dog Scratchings of the Pound and all other pertinent paperwork and records of the Pound. Distribute or read the Dog Scratchings (minutes) at each Growl.

Keep the financial records of the Pound, and reading the Bones (Financial) Report at each Growl.

Perform the banking of the Pound, using generally accepted accounting practices and policies as outlined.

Be the eyes and ears of the Pound. The Dog Robber should report to the Pound Keeper any problems that arise or exist. As the Dog Robber is an appointed position, working together with the Pound Keeper is vital to the smooth operations and betterment of the Pound.





THE DUTIES OF THE PACK DOG ROBBER

General

The name of the Pack in which you and your Pounds are to be a member of is to be known as the 'your State name' Pack (e.g. Michigan Pack).

A separate checking account bearing the name of your Pack should be maintained with a reputable FDIC bank or other FDIC financial institution.

- 1. This account should require two (2) signatures on every check.
- 2. It is suggested that three (3) Officers be authorized to sign: Worthy Pack Leader, Worthy Sr. Vice Pack Leader and Worthy Dog Robber. Having the extra signature protects against problems with illness, absence or distance.

The Worthy Dog Robber should possess a rubber stamp containing the name of the Pack and an appropriate phrase (such as "for deposit only") to deposit all checks received. If possible, this stamp should include the account number.

All checks for the various Order accounts should be made payable as follows:

- 1. For all activity with the Kennel Quartermaster, all payments should be made payable to the "Kennel Quartermaster".
- 2. For all activity with the Kennel Dog Robber, all payments should be made payable to the "Kennel MODD".
- 3. For other Pound, Pack and Kennel activities, including fund-raisers, information should be presented for the appropriate payment designee.

All forms are available on the Kennel Web Site at www.moddkennel.com These forms are interactive and may be filled out online. Print as many copies as you need.

Transmittals

All transmittals must be processed in a timely fashion. It is very important that the Worthy Dog Robber sends all transmittals immediately upon receipt from their Pounds to the Kennel Dog Robber without delay. All transmittals must be completed in their entirety. Worthy Dog Robbers are asked to double check information received as accurate. Note any change of address information for your records. Keep the Pack copy, forward all other copies with the check for the Kennel Dues to the Honorable Kennel Dog Robber.





Advancement Forms

All advancement forms must be completed in their entirety. Worthy Dog Robbers are asked to double check information received as accurate. In the case of advancement requests for the upcoming Supreme Growl: (NOTE: Pups may request advancement to Devil Dog at the Mid-Winter Mini-Growl and at the Supreme Growl.)

- 1. The Worthy Dog Robber will complete, date and sign the top section. Ensure it is filled out properly.
- 2. Ensure the applicant has completed the medical portion of Section II, signed the form and leave the rest of the form blank.
- 3. The Worthy Dog Robber shall mail the completed package to the Kennel Dog Robber for further processing. Keep the bottom copy of this form for the Pack's records until the endorsed copy is returned from Kennel.
- 4. Please make a copy of the completed form for the advancing dog to bring to the Supreme Growl.
- 5. All forms must be received by the Kennel Dog Robber by 1 July.

(DO NOT SEND ANY ADVANCEMENT FEES AT THIS TIME, THEY WILL BE COLLECTED AT KENNEL HEADQUARTERS DURING THE REGISTRATION PHASE.)

All forms should be processed speedily. Delays may deprive a member of their next advancement in Degree at an upcoming Grand or Supreme Growl. Mistakes and omissions are more easily corrected at the Pound and Pack levels prior to any mailings.

Requests for Transfer

Upon receipt of requests for transfer:

- 1. The Worthy Dog Robber of the losing Pack should file the paperwork received for future reference.
- 2. The Worthy Dog Robber of the gaining Pack should keep the appropriate copy (including the transmittal copy as applicable) and forward the remaining documents to Kennel Dog Robber without delay.

Pack Officer Installation Reports

Immediately after the election of Pack Officers, the Worthy Dog Robber will complete the Officer Installation Form in its entirety. Be sure to complete all of the required information. The Bylaws clearly state eligibility requirements for each office (Article 111 Section 208).

Upon completion of the Installation, the Worthy Dog Robber will have the Installing Officer sign the form. The Worthy Dog Robber will then detach and mail the appropriate copies to the Kennel Dog Robber.

A copy should be made available for the Worthy Pack Leader for their records, as well as a copy to be sent to each Pound within the Pack.





For future reference, the Worthy Dog Robber should keep one copy of the Installation Report on hand at all Growls of the Pack. Remember that the Pack Leader must have the Degree of Pedigreed Devil Dog. A temporary exception to this can be found in the MODD BYLAWS, ARTICLE III -- PACKS -- SECTION 308, PARAGRAPH A (1). All other Pack Officers must be either Pedigreed Devil Dogs or Devil Dogs.

Incorporation

Each Pack must obtain an EIN number from the Internal Revenue Service and then obtain incorporation as a non-profit organization in their state. This is normally handled by the Secretary of State office. This will help protect the members from liability on an individual basis.

Federal Taxes

Each Pound must file taxes annually just as an individual must. Send your EIN number to the Kennel Dog Robber. That office will forward the number and your other information to the MCL headquarters. They will request the IRS to include your Pound on the list of subsidiary organizations of the MCL. Once that is accomplished you will be able to file a 990N tax postcard annually. If you do not follow these steps you will have to Request a separate determination from the IRS to find you are a non-profit and then file a 990EZ annually. Report your successful filings to the Kennel Dog Robber.

IRS Requirements

Perform the banking of the Pack, using generally accepted accounting practices and policies as outlined.

Be the eyes and ears of the Pack. The Worthy Dog Robber should report to the Worthy Pack Leader and Staff any problems that arise or exist. As the Worthy Dog Robber is an appointed position, working together with the Pack Leader and Staff is vital to the smooth operations and betterment of the Pounds and the Pack.

All forms are available on the Kennel website. All Pounds and Packs are encouraged to use the electronic versions.





SO HOW DO I ...

Apply for a new Pound Charter?

Kennel Bylaws discuss this subject in full in Article II Section 202. Please note that you should follow either A/B/C/E or A/B/D/E depending on if there is a functioning Pound in your area. Charter applications may be received from your Division Vice Chief Devil Dog. Charter Application Fees are stated on the application. All checks are to be made payable to "Kennel MODD". Please note that the application MUST be completed and signed by seven members of the Order, five or more members with the Degree of Devil Dog or Pedigreed Devil Dog. Each member must indicate their degree and dog tag before their name is placed on the form.

Apply for a new Pack Charter?

Kennel Bylaws discuss this subject in full in Article III Section 302. Please note that you should follow either A/B/C/E/F/G or A/B/D/E/F/G depending on joint or separate applications. Charter applications may be received from your Division Vice Chief Devil Dog and are the same form as for a new Pound. Charter Application Fees are stated on the application. All checks are to be made payable to "Kennel MODD". Please note that the Pound Keeper and Pound Dog Robber of each Pound MUST complete the application. Each signing member should indicate their degree and dog tag before their name is placed on the form.

Re-instate old members that do not remember their dog tags or degree?

Kennel has all records from the beginning of the Order on file with the Kennel Dog Robber. If possible, ask the member where they received their initiation; month, year and city; see if they have an old membership card; check Pound and Pack records for prior years for dues transmittals or advancement forms. Send as much information as possible with the request for research. This may be a lengthy process and carries no implied guarantee of success.

Reinstate members and transfer them into a new Pound that I am forming?


