- Final Election Code Community Ratification Process
- Submit Custom Code conversion package to Headquarters
- Ministerial Order Removing FN from Electoral Provisions of *Indian Act*
- Registration of Order under Statutory Instruments Act






Ministerial Order Removing FN From Electoral **Provisions of Indian Act**

- Headquarters submit a conversion package to the Minister for her approval before she signs the Order. This information received from Band includes:
 - BCR requesting the Department remove the FN from section 74 of the Indian Act
 - copy of the Final Election Code
 - evidence of community sessions to discuss the Election Code (dates, locations, etc)
 - documentation on the ratification vote held (voters list, ballot used, etc)
- As the electoral period in a custom code is likely to be in the 90 day ballpark, the "conversion package" must be submitted a full seven months before the end of the band council's term of office.





Elections – Indian Act vs FNEA

Indian Act

- Term of office; 2 years
- No provisions for common election date
- To be nominated as a councillor/Chief, must be 18+
- To accept nomination; Candidate does not have to be present, unless candidate withdraws
- Candidacy Withdrawal; anytime prior to close of polls or by writing declaration of withdrawal
- Advance polls;

First Nation Flection Act

- Term of office; 4 years
- Common election date provision for 6 or more FN
- To be nominated as a Candidate for any position must be at least 18 years of age
- To accept nomination, candidate's duty to accept and person nominated must submit all documentation
- Candidate withdrawal; any time prior to poll and/or a death of a candidate



Election Timeline – Indian Act vs FNEA

- Day 79 Appointment of EO
- Day 72 Notice of Nomination Date posted and mailed to off reserve
- Day 42 Nomination Meeting
- Day 37 deadline for nominees to withdraw
- Day 35 Ballots mailed to off reserve
- Day 0 Election Date
- Day -1 Recount if required
- Day -45 deadline for appeals

- Day 65 Voters list/addresses to EO
- Day 60 Notice of Nomination Date posted and mailed to off reserve
- Day 35 Nomination Meeting
- Day 32 Deadline for declaration of candidacy
- Day 30 Ballots mailed to off reserve
- Day 6 Last day for EO to receive requests for mail in ballots and send them out
- Days 10 to 5: Potential advance polls
- Day 0: Election Date
- Day -1: Recount if necessary
- Day -30: deadline for appeals
