

The Imperium Key — Reference Key of Terms (Public Equivalency Glossary)

Purpose

This companion glossary is provided to ensure that the stylized doctrinal naming conventions used throughout the Lex Imperium portfolio are interpreted without ambiguity in conventional legal, corporate, and administrative terminology.

This deposit (“Lex Imperium”) contains internally adopted and externally recognized corporate governance instruments of **Brandon Michael Jeanpierre Corporation (Delaware)**, d/b/a **The Black Flag**.

Certain documents are titled using internal codex-style designations. The following terms are expressly equivalent to standard corporate instruments.

I. Foundational Corporate Instrument Equivalencies

Internal Term (Lex Imperium)	External Legal Equivalent
The Founding Veil	Certificate of Incorporation / Articles of Incorporation (Delaware)
The Covenant Codex	Nonprofit Bylaws and Governance Code of Brandon Michael Jeanpierre Corporation
Lex Imperium	Master compiled corporate governance portfolio and doctrinal archive (this deposited work)
Immutable Concord of the Umbral Thread	Adopted Corporate Decree / Governance Resolution asserting doctrinal-corporate unity
Umbral Thread	Integrated governance framework and protective operating architecture of the corporation

II. Federal Recognition and IRS Instrument Alias Key

Internal Term	External Administrative Equivalent
Sigil of Recognition	IRS 501(c)(3) Determination Letter (tax-exempt status recognition)
Shadow Proclamation	IRS EIN Assignment Letter (federal entity identification issuance)

These instruments constitute formal federal recognition of the corporation’s existence and charitable classification.



III. Governance Bodies and Corporate Authority Terms

Internal Term	Standard Corporate Equivalent
Sovereign Loom	Board of Directors / Governing Body
Convergence	Formal Board Meeting / Convened Session
Blood of the Coven	Advisory Council / Internal Peer Review Body
Circle of the Thread	Subsidiary or affiliated operational entity within the corporate structure

IV. Officer Titles and Stylized Designations

Certain internal ceremonial titles correspond to conventional corporate officer roles:

Internal Title	Standard Corporate Role
Shadow Sovereign	Chairperson / Principal Officer
Eclipsarch	Vice Chair
Keeper of the Codex	Secretary
Warden of the Vault	Treasurer

Such titles do not alter the underlying legal function of the officer positions; they are stylistic equivalents within the governance doctrine.

V. Decrees, Codices, and Record Instruments

Internal Term	Conventional Legal Meaning
Codices	Corporate records, adopted governance texts, and operating instruments
Decree	Board Resolution or formally adopted governance action
Attestation and Seal	Execution clause with corporate seal and signature authority
Universal Notice	Public declaration intended to establish constructive notice of authorship, compilation, and governance provenance
