#### Purpose of the Meeting

The meeting convened to discuss, draft, and approve the Witches Circle Governance Document as a formal addition to the organizational bylaws of the Brandon Michael Jeanpierre Corporation, DBA The Black Flag. This document aims to solidify governance structures, address compliance with Delaware corporate law and IRS 501(c)(3) standards, and integrate thematic and operational enhancements reflective of The Black Flag's ethos.

Additionally, the meeting sought to reconcile the governance framework with updates to the organization's business model, strategic plan, and financial projections, embodying a holistic integration of technology, business, art, human rights, and leisure.

Resolutions Passed

Resolution 1:

The Witches Circle Governance Document, as drafted and reviewed, shall be finalized and incorporated into the next bylaws revision as a supplement and formal article.

Timeline: The revised bylaws will be published after the beginning of the next fiscal year and before funding requests or further legal actions commence.

Resolution 2:

The document will emphasize:

Flare and melodrama in alignment with the organization's ethos.

Legally recognized governance to withstand legal challenges and demonstrate scalability.

Resolution 3:

The governance framework will act as a safeguard against misuse or misinterpretation, aligning with religious doctrine and corporate law.

Adjournment

The meeting adjourned at 10:36 PM on December 28, 2024, with unanimous agreement to proceed with the resolutions and finalize the governance structure for publication and integration into the organizational framework.
