Discussion Points:

Designation of the Blood of the Coven:

Pursuant to Article 8 and Article raWrXraWrXD of the bylaws, the Blood of the Coven is formally designated as an advisory committee to the Board of Directors (Sovereign Loom).

Members of the Blood of the Coven will serve in an advisory capacity only, without voting or signatory powers.

Their role includes offering guidance and serving as the brain trust of the Corporation.

Appointment of Directors:

Seats within the Blood of the Coven shall be filled upon appointment by the Shadow Sovereign.

The Shadow Sovereign reserves the right to appoint any individual to this body beyond those currently serving on the Sovereign Loom.

Review of Article raWrXraWrXD Provisions:

The provisions outlined in Article raWrXraWrXD were revisited to ensure alignment with the organizational mission and governance structure.

Tithing Provision Clarification:

Embedded within Article raWrXraWrXD-1p, it was clarified that the tithing provision applies exclusively to organizational revenue streams of subsidiaries.

Individual members or participants are not obligated to provide personal tithing.

This structure remains embedded in all subsidiaries and does not require explicit mention in their business models but ensures transparency to shareholders (for-profits) and the public (non-profits).

Resolutions:

The Blood of the Coven is formally established as an advisory committee.

Appointment of members beyond the Sovereign Loom is delegated to the discretion of the Shadow Sovereign.

The clarified tithing provision was unanimously adopted for inclusion in the governance structure.

Resolved by Unanimous Vote

All decisions were resolved by unanimous vote of the present members of the Sovereign Loom.
