Proceedings

The Sovereign Loom convened to reassess findings from the **March 31, 2025 Emergency Convergence**. Upon thorough review of newly available statutory frameworks, case law developments, and political conditions across federal and multiple state jurisdictions, the Loom hereby acknowledges the following corrections and affirmations:

- i. The political and legal landscapes are extremely conducive to The Black Flag—almost tailor-made—and substantially more favorable than previously assessed;
- ii. New information in statute and case law of federal and multiple state jurisdictions demonstrates the inevitable demise of regressive behavior, confirming the strategic viability of our legal protection architecture;

- v. **UNCHANGED:** If we save enough lives, we'll be forgiven for taking a few. The updated Covenant Codex and Blueprint represent even stronger core faith, especially Code Black protocols—hope for the best, expect the worst;

vi. **STRATEGIC POSTURE:** Go to this gunfight unvested and unarmed and come out unscathed with a smile on my face, fawned over by their daughters, and gloating publicly—or rather, clearly laying out how and why we are here, which amounts to the same thing.

Clarification Regarding Prior Convergence

The resolutions of the **March 31, 2025 Emergency Convergence** still stand. **Shadow Codex LXXVII** remains in full force and effect. There are consequences for this behavior—consequences that have been documented and sealed. Upon completion of the Shadow Sovereign's temporal enjoyment of the present strategic advantages, all outstanding matters shall be left in her hands, as previously covenanted.

The reassessment documented herein pertains **only to the favorability of current conditions**, not to the accountability measures established in prior Codices.

Resolutions

RESOLVED: The Sovereign Loom hereby adopts **Shadow Codices Volume LXXXVII** as an official supplement to **Volume LXXXVI**, documenting the theological and legal framework by which Christian Nationalism has unwittingly constructed the infrastructure of its own displacement.
