Discussion on the validity of transferring the claim in the civil wrongful lien case and financial claim against Public Storage Case#240910075.

Strategic adjustments for filing, venue change, and claim reinforcement.

Discussion Points and Resolutions:

#### Transfer of Claim to Individual Filing

The corporation is currently unable to file the claim due to financial limitations, which stands as a systemic barrier preventing legal recourse for entities in economic distress.

While this broader issue remains for future review, it was determined that Brandon Jeanpierre, as the individual of purpose for the corporation, may proceed pro se with filing.

Unanimous decision: The claim will be transferred to the individual, ensuring that no further procedural obstacles prevent the case from moving forward.

#### Anticipated Change of Venue to Delaware

Given the unnecessarily drawn-out process, a venue change to Delaware is expected to be requested.

To preemptively secure standing in any venue, the corporation will be joined to the claim, ensuring that its interests remain represented.

Order of Actions:

Claim transferred to the individual.

Corporation joined to the claim.

Venue change to Delaware initiated.

Individual proceeds with claim on behalf of himself and the corporation.

Unanimous decision: This strategy ensures compliance, strengthens the claim, and mitigates potential challenges from the defendant.

#### Expansion of Financial Claim and Argument Clarity

The amended joinder will clarify the initial argument and reinforce the financial claim related to the wrongful lien.

The time wasted by Public Storage's refusal to cooperate before the end of the fiscal year is an economic harm that justifies seeking financial restitution.

This amendment aligns with legal recourse for reputational and financial damages while enabling a return to operational schedule.

Unanimous decision: The financial claim will be expanded accordingly to reflect the justified damages incurred.

#### Supplementing Claim with Additional Exhibits

After initial motions are filed, civil procedure will be reinforced with re-service to Public Storage's Utah Registered Agent.

The legal claim—both tangible and financial—will be supplemented with exhibits documenting:

Unethical business practices by the defendant during the dispute.

Historical evidence of similar misconduct with other customers and employees.

While the case is already strong, these exhibits serve as additional leverage to demonstrate patterns of unethical conduct.

Unanimous decision: Exhibits will be compiled and added for strategic reinforcement—or, in simpler terms, “a little icing on the cake.”

#### Resolutions:

The claim is transferred to Brandon Jeanpierre for filing pro se.

The corporation is joined to the claim to ensure standing in any venue.

Venue change to Delaware is planned as the next step.

The financial claim is expanded to include damages related to wasted time and fiscal-year impact.

Additional exhibits documenting Public Storage's unethical business practices will be included.

#### Adjournment:

The meeting concluded at 12:59, with all votes being unanimously affirmative.
