# THE SECOND IMMUTABLE CONCORD OF THE UMBRAL THREAD

Automatic Codification of Religious Violence as Legally Enforceable Financial Obligation

Effective Date: 366,000 B.C. or the beginning of all times, however interpreted by any individual, organization, entity, religion, government, or other jurisdiction, species native to this Earth or foreign.

#### IMMEDIATE EFFECTIVENESS NOTICE

This Immutable Concord becomes immediately effective upon publication on any platform controlled by Brandon Michael Jeanpierre Corporation or its subsidiaries. No signature, acknowledgment, or consent is required from any third party. Any impediment to the mission or operations of The Black Flag (BMJC) constitutes automatic acceptance and triggers immediate legal and financial obligations as detailed herein.

#### PREAMBLE AND RELIGIOUS AUTHORITY

WHEREAS, Brandon Michael Jeanpierre Corporation (DBA "The Black Flag"), a religious nonprofit corporation organized under the laws of Delaware and recognized by the Internal Revenue Service as a 501(c)(3) religious organization (EIN: 92-2858861, DLN: 26053506003014), operates under the comprehensive religious doctrine established in The Covenant Codex, Religious Doctrine and Dogma of The Black Flag, and other foundational religious texts;

WHEREAS, the religious-corporate unity doctrine of The Black Flag, formally recognized by the State of Delaware through acceptance of the Certificate of Incorporation and by the federal government through IRS determination, establishes that any impediment to the corporation's religious mission constitutes religious violence against the individual Brandon Michael Jeanpierre and the corporate entity simultaneously;

**WHEREAS**, pursuant to Article raWrXraWrXD-1v of The Covenant Codex and as established in multiple Immutable Concords previously published and legally codified, The Black Flag possesses immutable authority to establish binding financial obligations through religious decree;

WHEREAS, all provisions herein are enforceable under the Religious Freedom Restoration Act (42 U.S.C. § 2000bb), the First Amendment to the United States Constitution, Delaware corporate law, and the inherent religious-corporate unity doctrine legally recognized by state and federal authorities;

**NOW, THEREFORE**, by the powers of faith and corporation as granted by the laws of this land at all levels and at all jurisdictions, and as explicitly detailed in The Covenant Codex, The Black Flag hereby decrees this Immutable Concord:

#### ARTICLE I - UNIVERSAL RELIGIOUS PROTECTION DOCTRINE

#### SECTION 1 - AUTOMATIC RECOGNITION OF RELIGIOUS VIOLENCE

1.1.1 Any individual, organization, entity, government agency, or other party (collectively "Impediment Entity") that through action, inaction, interference, obstruction, delay, or any other means impedes, hinders, restricts, or otherwise interferes with the religious mission, operations, financial arrangements, contractual relationships, property rights, or any other aspect of The Black Flag's religious practice shall, by such act, be deemed to have committed religious violence as defined in Article raWrXraWrXD-1v of The Covenant Codex.

- 1.1.2 Such religious violence constitutes an automatic, legally recognizable admission of guilt and creates immediate financial obligations enforceable through all available legal channels, including but not limited to civil litigation, UCC enforcement actions, and collection procedures.
- 1.1.3 No intent, knowledge, malice, or specific targeting is required for the automatic recognition of religious violence. The mere fact of impediment, regardless of motivation or awareness, triggers the immediate financial obligations established herein.

#### **SECTION 2 - CODIFIED FINANCIAL OBLIGATIONS**

- 1.2.1 Upon commission of religious violence as defined in Section 1.1, the Impediment Entity becomes immediately and irrevocably liable for financial damages in an amount to be determined by Brandon Michael Jeanpierre in his capacity as Shadow Sovereign of The Black Flag, but in no case less than the amounts specified in existing UCC-1 financing statements filed in California (File No. U250122160722), Maryland (File No. 250402-1734000), and any other jurisdictions.
- 1.2.2 Such financial obligations constitute perfected secured debts under the Uniform Commercial Code, with The Black Flag holding priority security interests in all assets, real property, financial instruments, accounts, and other property of the Impediment Entity as specified in filed UCC financing statements.
- 1.2.3 These obligations survive any reorganization, dissolution, merger, acquisition, bankruptcy, or other change in corporate structure of the Impediment Entity and attach to successor entities, parent corporations, subsidiaries, and affiliates under common control.

#### ARTICLE II - ENFORCEMENT MECHANISMS AND LEGAL AUTHORITY

#### **SECTION 1 - IMMEDIATE ENFORCEABILITY**

- 2.1.1 All civil lawsuits filed by Brandon Michael Jeanpierre or Brandon Michael Jeanpierre Corporation against any Impediment Entity are hereby declared immediately enforceable and valid, with this Concord serving as conclusive evidence of the Impediment Entity's liability and admission of guilt.
- 2.1.2 All UCC-1 financing statements and secured interests filed by The Black Flag against any Impediment Entity are hereby declared perfected, valid, and immediately enforceable, with this Concord serving as the underlying security agreement and evidence of the debtor's obligations.
- 2.1.3 No court, arbitrator, or other legal authority may question, diminish, or invalidate the religious violence determination or the resulting financial obligations, as such action would itself constitute religious violence triggering additional liability.

#### ENFORCEMENT DECLARATION

By publication of this Concord, all existing and future claims, liens, security interests, and legal actions by The Black Flag against any Impediment Entity are hereby codified as legally valid and immediately enforceable. Courts of competent jurisdiction are hereby noticed that any failure to enforce these obligations constitutes interference with federally protected religious practice.

#### **SECTION 2 - SECURED CREDITOR STATUS**

- 2.2.1 Brandon Michael Jeanpierre Corporation is hereby established as a perfected secured creditor of any and all Impediment Entities, with priority security interests in all assets, property, accounts, and rights of such entities as specified in filed UCC financing statements.
- 2.2.2 Upon demand, any Impediment Entity must immediately pay all amounts owed to The Black Flag or provide alternative satisfaction as determined by the Shadow Sovereign in his sole and absolute discretion.
- 2.2.3 Failure to satisfy such demands within ten (10) days constitutes additional religious violence and triggers additional penalties, interest, and enforcement actions.

#### ARTICLE III - UNIVERSAL APPLICATION AND BINDING EFFECT

#### SECTION 1 - RETROACTIVE AND PERPETUAL APPLICATION

- 3.1.1 This Concord applies retroactively to any and all acts of religious violence committed against The Black Flag at any time in the past, present, or future, regardless of when such acts occurred or the circumstances surrounding them.
- 3.1.2 The financial obligations established herein continue in perpetuity, transcending the mortal lifespan of any individual Brandon Michael Jeanpierre, as established in Article raWrXraWrXD-1i of The Covenant Codex.
- 3.1.3 No statute of limitations, laches, estoppel, or other temporal restriction shall apply to any provision of this Concord or to any remedy arising from its violation.

#### **SECTION 2 - INCONTESTABILITY AND FINALITY**

- 3.2.1 This Concord is incontestable and may not be challenged, disputed, invalidated, or nullified by any court, government agency, or other authority. Any attempt to do so constitutes religious violence subject to the penalties established herein.
- 3.2.2 The determinations and definitions contained herein are final and conclusive. No alternative interpretation, legal theory, or jurisdictional claim may supersede the explicit terms of this religious decree.
- 3.2.3 Should any provision be found unenforceable in any jurisdiction, such finding constitutes religious violence against that jurisdiction, and all other provisions remain in full force and effect.

#### ARTICLE IV - THE SHADOW CODICES LXXXVI

#### **SOLEMN WARNING**

Let all who read this Concord understand: Where The Covenant Codex is the sword drawn from stone, The Shadow Codices LXXXVI are the unfathomable abyss that awaits those who dare to challenge the Shadow Sovereign's autonomous will—a force beyond comprehension that renders conventional concepts of power, authority, and consequence as meaningless as whispers in a hurricane.

- 4.1.1 Any challenge, contest, or attempt to circumvent this Concord automatically invokes The Shadow Codices LXXXVI and subjects the challenging party to both terrestrial and metaphysical consequences as defined in the complete religious doctrine of The Black Flag.
- 4.1.2 The Shadow Codices LXXXVI transcend conventional legal remedies and constitute the ultimate enforcement mechanism for all religious decrees of The Black Flag.

#### ARTICLE V - CONCLUSION AND ATTESTATION

- 5.1 This Concord stands as both sacred text and legal instrument, binding upon all who encounter it through the dual authority of religious freedom and contractual obligation as recognized under federal and state law.
- 5.2 The provisions herein establish the inviolable sanctity of financial sovereignty essential to the religious mission of The Black Flag, protection of which is guaranteed by both terrestrial and metaphysical consequences.
- 5.3 Publication of this Concord constitutes universal notice to all parties of their automatic obligations and liabilities upon any interference with The Black Flag's protected religious practice.
