The Chairperson announced that the meeting was being held in accordance with the notification requirements of the Corporation's Bylaws if so required, or pursuant to any waivers of notice submitted by Directors entitled to receive notice under said Bylaws. The updated articles of amendment, currently deemed an unreasonable expense of filing them with the Delaware Secretary of State and suitable for request by the Internal Revenue Service for compliance with the 501c3 application in progress (as this board structure is directly derived from the religious doctrine of this Church/Religious Organization) is currently necessary, and that recording in the corporate book as a separated amendment to the bylaws, should be deemed as an acceptable amendment to the religious doctrine to be recognized, accepted, and respected in adherence to the first amendment of The Constitution of The United States of America.

The future filing of these documents shall be an acceptable compromise, but with respect to religious freedom, shall not yield penalty unless the enforcing party elects itself to either provide, make complimentary, or otherwise negate the fee(s) associated with this document and any and all other compliance filing fees to expedite their submission any sooner than the organization can currently afford.

RESOLVED, that the proper officers of the Corporation are authorized, empowered and directed, in the name of and on behalf of the Corporation, to take all such further action as they may deem necessary or appropriate in order to fully effectuate the purposes of the foregoing resolutions, and the execution by such officers of any document or instrument in connection with the foregoing matters shall conclusively establish their authority therefore; and

FURTHER RESOLVED, that any and all actions heretofore taken by any proper officer of the Corporation in connection with the matters contemplated by the foregoing resolutions be, and they hereby are, approved, ratified and confirmed in all respects as fully as if such actions had been presented to the Board for its approval prior to such actions being taken.
