Plaintiff Brandon Michael Jeanpierre respectfully submits this Emergency Supplement to his Motion for Correction (ECF No. 19) to alert the Court that nearly one week has passed since the critical April 18, 2025 religious deadline identified in The Black Flag's religious texts, and the Motion for Correction has been pending for four days without ruling, causing compounding religious harm that increases daily.

### ESCALATING RELIGIOUS HARM

The passage of time since the critical April 18, 2025 religious deadline has substantially increased the religious harm inflicted upon The Black Flag, a properly recognized religious entity. As extensively documented in Exhibit T (Blueprint for Global Expansion and Social Transformation) and Exhibit OOOOO (Climate Projections), the April 18, 2025 date represented a mandatory activation deadline for three essential religious subsidiaries ("Circles of the Same Thread") that form the core of The Black Flag's religious mission.

Each day of continued detention of sacred religious property beyond this critical deadline compounds the harm in measurable ways:

1. The initial projected damages of \$41,317,426.12 were based on immediate resolution by the April 18, 2025 deadline. The passing of this deadline without relief

has now increased damages to \$64,973,140.19 as detailed in the Memorandum of Irreparable Harm.

2. Implementation costs for religious subsidiaries increase exponentially rather than linearly with each passing day, as community-based programs require substantial recalibration when launched outside their mandated religious timelines.

3. The religious mission's time-sensitive nature is directly tied to climate resilience concerns documented in Exhibit OOOOO, which establishes that delays in implementation have cascading effects on the religious mission's viability.

4. While 10% of damages (\$6,497,314.02) would have been sufficient for immediate relief if granted on April 18, 2025, the six-day delay now necessitates 25% (\$16,243,285.05) to enable the religious corporation to overcome the compounding obstacles created by missing the sacred deadline.

## CRITICAL TIMING CONSIDERATIONS

The financial mechanics underlying this emergency situation are grounded in religious implementation requirements established in The Black Flag's religious texts:

1. By April 30, 2025 (six days from today), The Black Flag must secure physical headquarters space in Milwaukee, WI as mandated by its religious texts, requiring immediate capital availability for down payment and securing financing.

2. Leasing opportunities for secondary sites in Salt Lake City—essential for the religious mission as detailed in Exhibit OOOOO—expire on April 30, 2025, with alternatives requiring substantially higher investments due to seasonal market fluctuations.

3. The release of funds by the date specified would enable The Black Flag to commit to leasing opportunities for physical spaces while minimizing the compounding harm to its religious mission.

4. The timing of relief is itself religiously significant, as The Covenant Codex explicitly establishes that sacred missions must be implemented according to specific timeframes to fulfill their religious purpose.

## UPDATED RELIEF REQUESTED

In light of the escalating religious harm caused by continued detention of sacred property and the Court's delay in ruling on the Motion for Correction, Plaintiff respectfully requests that the Court:

1. Grant the Motion for Correction (ECF No. 19) immediately and without further delay;
2. Order the immediate return of all religious property to Plaintiff within 24 hours;
3. Order payment of damages in the increased amount of \$16,243,285.05 (25% of total damages claimed) within 24 hours to enable the performance of religious activities that can no longer be delayed due to the passage of the April 18, 2025 religious deadline;
4. Set an expedited hearing on Plaintiff's request for a Preliminary Injunction to address the remaining damages and ensure no further religious harm is inflicted.

## CONCLUSION

For the foregoing reasons, Plaintiff respectfully requests that this Court grant the immediate relief requested herein to prevent further irreparable religious harm from continuing to compound with each passing day.
