Discussion Points and Resolutions:

Withdrawal of Motion to Change Venue

The corporation had previously decided to withdraw the Motion to Change Venue to Delaware Superior Court, as communicated via email on 2/20/25

Procedural challenges were identified in finding the appropriate filing for a withdrawal

Defendant's attorney had subsequently filed an objection to the motion regardless

Strategic assessment determined that expeditious resolution in the current venue outweighs potential benefits of venue change

Maintaining the case in its current jurisdiction avoids procedural delays that would further impede resolution

Documentation of Withdrawal Decision

Despite the decision to withdraw, formal documentation in the corporate record was deemed necessary

Transparency considerations support placing this decision in the official minutes

This documentation fulfills quarterly minute requirements and provides necessary corporate governance transparency

Unanimous decision: The withdrawal decision shall be formally recorded in these minutes for both corporate and potential judicial review

Timeline for Filing "Motion to Void Lien Sale for Religious Violence"

Target filing date established as before work hours on Friday, 3/21/25

Decision regarding request for hearing to be finalized before EOD Thursday, 3/20/25

Urgent expeditious resolution is deemed critical to organizational interests

Time sensitivity acknowledged due to substantial operational delays already incurred

Strategic Reconsideration of Delaware Venue

The immediate priority is resolving the matter in current jurisdiction

However, if resolution is not achieved by the end of the current quarter, strategic reconsideration of Delaware Superior Court and federal court options will be implemented

The delay has incurred substantial damages to organizational operations

The corporation reserves all rights to pursue additional legal remedies should timely resolution not be achieved

Resolutions:

The prior decision to withdraw the Motion to Change Venue to Delaware Superior Court (communicated on 2/20/25) is hereby formally documented and reaffirmed.

The "Motion to Void Lien Sale for Religious Violence" shall be filed before work hours on Friday, 3/21/25.

Decision on whether to request a hearing will be finalized before EOD Thursday, 3/20/25.

Should resolution not be achieved by the end of the current quarter, the corporation reserves the right to file new actions in Delaware Superior Court and federal court seeking additional damages for continued organizational impact.

These minutes shall be included as an exhibit in upcoming court filings to document the corporation's good faith efforts toward efficient resolution.

Adjournment:

The meeting concluded at 21:07, with all votes being unanimously affirmative.
