- 1. Overview and plans for more than 3,400 and perhaps more than 7,000 4G/5G cell network antennas throughout the City of Winnipeg – estimates are that more than 50 antennas would be installed in Wolseley • Lyle Barkman: Local business owner and resident.**

Why we need to keep 4G/5G radiation emitting antennas out of our neighbourhood

- 393 scientists and medical doctors from more than 40 countries are warning the public that *“5G will substantially increase exposure to radiofrequency electromagnetic fields ... that has been proven to be harmful for humans and the environment.”* They have asked the European Union to stop the deployment of 5G technology *“until potential hazards for human health and the environment have been fully investigated by scientists independent from industry.”*

- The 5G rollout has been halted in Brussels, Belgium, and parts of Italy and Switzerland until adverse health and environmental consequences can be more fully investigated.
- Scientists and doctors, including Dr. Anthony Miller, a Canadian MD, epidemiologist and former advisor to the World Health Organization, have stated that recent scientific evidence supports identifying radiofrequency radiation, including the 5G frequencies, as a hazard that is known to be *“carcinogenic to humans”* (the same as asbestos and cigarette smoking). Children are particularly vulnerable.
- In May 2019, Dr. Riina Bray, Medical Director of the Environmental Health Clinic/Women's College Hospital in Toronto, Ontario issued this statement: *“My clinic is already assessing patients from across Ontario who are sensitive to microwave radiation from their wireless devices including cell phones, Wi-Fi, and an increasing number of smart appliances...We expect 5G to add to this burden.”*
- More than 30 peer-reviewed scientific studies show DNA damage, and 3 reviews and meta-analyses show sperm damage from radiofrequency radiation emission levels that Health Canada claims are safe.
