Say “no” to installation of 4G/5G cell antennas (cell “towers”) in residential areas

BACKGROUND

5G (fifth generation technology) wireless networks:

- Are not just an upgrade. 5G will use and add more of the 2G, 3G and 4G wireless frequencies currently in use by many wireless devices, such as cell phones, plus add higher-frequency waves in order to transmit more data, faster.
- A full rollout would result in thousands of small cell antennas, **equivalent to hundreds of cell towers, throughout residential neighbourhoods and public spaces within the City of Winnipeg.**
- It would mean a massive increase in exposure (firsthand & secondhand) to radiofrequency (RF) radiation, whether or not you use the service.
- There are no human health studies on long-term safety of 5G exposures.
- In some municipalities across Canada, private companies are now installing so-called “small cell antennas” (the first phase of 5G infrastructure) on “non-tower structures” such as lamp posts and utility poles, on streets and back lanes close to homes and in public spaces, without any notification or public consultation.
- Some antennas are less than 10 meters from homes, some above the sidewalk directly in front of homes.
- Indications are that 5G roll out is underway in Winnipeg.
- There are alternatives such as fiber-optic networks that are safer, faster and more cyber-secure.
- Scientists and doctors from more than 40 countries, including Canada, continue to warn that there are serious health risks of everyday RF radiation exposure, such as cancer, diabetes, headaches, heart disease, infertility, memory problems, nausea sleep disorders, and tinnitus.
- Remember asbestos, cigarette smoking, and thalidomide?

CANADIAN SAFETY STANDARDS ARE OUTDATED

They are based on Health Canada’s obsolete “Safety Code 6”

TWO APPEALS TO HEALTH CANADA IN 2014 WHEN SAFETY CODE 6 WAS REVISED -

1. 52 INTERNATIONAL SCIENTISTS: **“Canada’s Safety Code 6 Guideline is fundamentally flawed...it is... obsolete...”**
 2. 55 CANADIAN MEDICAL DOCTORS CALLED FOR HEALTH CANADA TO PROVIDE: **“Wireless safety standards that are more protective of the health of Canadians.”**
- ALL IGNORED.**

ONTARIO DOCTORS, MAY 30, 2019, PRESS RELEASE - Dr. Riina Bray, Medical Director of the Environmental Health Clinic/Women's College Hospital in Toronto, Ontario: **“My clinic is already assessing patients from across Ontario who are sensitive to microwave radiation from their wireless devices including cell phones, Wi-Fi, and an increasing number of smart appliances...We expect 5G to add to this burden.”**
