On the northeast corner of the soccer field, there is an access panel or some sort of square/rectangular area that is immediately adjacent to the touchline of the soccer field at the junction with the goal line. This access panel is directly in the path of the assistant referee.

Last night, I injured my right ankle while running to the goal line to be in position to make a call; however, as I ran, I did not expect the sudden drop from the rest of the surface of the field. Referees and the athletes are not going to be looking at the ground, and it is directly in the assistant referee's path--and in an area with the assistant referee has to make hard stops with focus up and across the field. In short, this is a safety issue for officials and athletes.
