## Hi Making Waves for Democracy!

As we are all well aware, we stand at a pivotal moment in our nation's history, where the future of our democracy and the rights we've fought so hard to secure hang in the balance while other rights are already eroding.

One of those cases is **Murthy v. Missouri**, which challenges the federal government's authority to work with social media companies to combat misinformation. Alliance for Hippocratic Medicine**, a case that questions the FDA's authority to approve and regulate mifepristone, a critical medication for abortion and miscarriage management. If the Court restricts the FDA's authority, it could pave the way for more stringent regulations on reproductive health services, undermining women's rights to make decisions about their own bodies. And that isn't the only abortion related case before the Court this year, in **Moyle v. United States** the court may decide that EMTALA, the federal law requiring hospitals to provide life

saving care to patients, applies to women dying in childbirth and who need an emergency abortion.

In **United States v. Rahimi**, the Supreme Court is reviewing whether individuals subject to domestic violence restraining orders can be prohibited from possessing firearms or if that violates the Second Amendment. The central question is whether this federal law aligns with historical traditions of firearm regulation, as interpreted under the 2022 *Bruen* decision.

The real-world impact of the Court's decision could be significant: upholding the law would maintain current protections for domestic violence victims, potentially saving lives, while striking it down could increase access to firearms for individuals under restraining orders, potentially heightening the risk of gun violence in domestic settings.

In **Trump v. United States** the court will decide whether the President of the United States is immune from prosecution and whether or not we are indeed a nation of laws.

Lastly, in **Garland v. Cargill**, the Court will determine the legality of bump stocks, devices that effectively turn semi-automatic rifles into fully automatic weapons. This case has significant implications for gun control and public safety. Upholding the ban on bump stocks is essential for preventing mass shootings and protecting our communities from gun violence.

These cases highlight the broader agenda at play—a concerted effort to roll back key rights and dismantle regulatory protections that have been cornerstones of our progress. The Supreme Court's decisions this term could reshape our society in profound ways, and we must be vigilant.

This is why it is so important to hold the Senate and flip the House. A Democratic majority in Congress can act as a critical check on the Court's

decisions, ensuring that we continue to protect and expand the rights of all Americans. Moreover, reelecting President Biden is not an option for us. His administration is committed to appointing judges who uphold the principles of justice, equality, and the rule of law. Just last week President Biden surpassed FDR in the number of justices appointed to the federal courts.

We are on the cusp of a new era of conservative rulings that could undo decades of hard-won victories.
