The Duke It Out Boxing Club is now a non-profit organization with over 20 boxers and offers a safe and bully free environment that teaches kids the fundamentals of boxing, the tools they need to succeed in life by building confidence, self-esteem, respect and discipline. His goal is to help them achieve physical and mental goals they didn't think was possible. Most of the kids that attend have been bullied, have self-esteem issues and working with them can change their life by giving the confidence they need to help get them in shape and at the same time help them improve their grades, become more outgoing, have life goals, happiness and help them be part of a Brother/Sister Hood that will last a lifetime; and,


WHEREAS, the 3 coaches at Duke It Out Boxing Club are all volunteers helping kids stay off the streets, away from gangs, drugs and preparing them to be future leaders of our community. Head Coach Andres Luis, aka, "Duke" is a graduate of Miller High School and is a 5 - time Golden Glove Champion, he also attended the 1992 Olympic trials for boxing when Oscar De La Hoya attended. Assistant Coach Joe De La Paz, aka, Coach Joe is a graduate of Moody High School and is an amateur boxer and was also a contestant at the 2001 Tough Man Contest. Training coach Eric Martinez, aka, Coach Eric is a graduate of Mathis ISD and was named 2006-2007 1st team all-district defensive back and the 2008 record holder for the 800M relay for Mathis ISD; and,




