# "Massive Human Rights Violations in Times of War: Legal, Political and Ethical Dilemmas for Europe"

### Synopsis and background to the discussions

Russia's full-scale aggression against Ukraine has generated a pattern of systematic human rights violations that coherently align with recognised indicators of genocidal intent. The objective extends beyond territorial acquisition: it seeks to dismantle Ukraine's institutional capacity, extinguish its statehood, and erode the Ukrainian people's existence as a distinct political nation. These dynamics directly challenge the stability of the European security architecture and the credibility of the international human rights system.

This conference focuses on two interlinked elements that reshape understandings of atrocity crimes:

- Environmental Devastation (Ecocide): the large-scale, deliberate degradation of ecosystems, water and energy infrastructure, agricultural land, industrial sites, and urban environments has created enduring risks to public health, food security, and regional stability. The breadth and intentionality of this harm expose gaps in existing legal classifications and accountability mechanisms for environmental crimes in armed conflict;
- Cultural Erasure (Cultural Genocide): systematic attacks on cultural institutions, heritage sites, archives, educators, artists, and linguistic identity are aimed at erasing Ukraine's cultural continuity and weakening societal resilience. The conflict demonstrates how cultural destruction functions as a strategic instrument of domination, revealing limitations within current international protective regimes for cultural heritage.

Together, environmental devastation and cultural erasure undermine two foundational rights that structure modern democratic societies: the right to a safe, liveable environment and the right to preserve cultural identity. Their erosion produces cascading effects across civil, political, economic, and social rights, thereby threatening the integrity of national and regional governance systems.

International community and European states have mobilised a multi-layered response—legal action before international courts, targeted sanctions, political backing for Ukraine's European trajectory, and significant humanitarian support to Ukraine. However, the evolving nature and scale of violations raise critical policy and research questions requiring coordinated, cross-sectoral reflection:

- How should evidence-gathering, qualification, and prosecution of atrocity crimes be adapted to address environmental destruction and cultural erasure within existing international legal frameworks? Are these frameworks sufficient or should they be enhanced?
- What enhancements to sanctions regimes are required to increase costs for actors engaged in environmental devastation, cultural suppression, and forced assimilation?
- How can a European-led reconstruction framework embed environmental restoration, cultural recovery, and institutional resilience from the outset?
- What targeted support should be prioritised for Ukrainian civil society, cultural institutions, and environmental defenders to sustain national resilience and accountability efforts?
- What strategic communication tools are needed to effectively counter denialism, disinformation, and narrative manipulation surrounding the war?
- What preventative architectures—legal, political, and institutional—must be strengthened to ensure that similar patterns of violations cannot recur within Europe or its neighbourhood?

Addressing these questions is essential for reinforcing Europe's normative commitments, strengthening the international rules-based order, and ensuring that accountability, reconstruction, and long-term security are approached as mutually reinforcing objectives. At stake is not only the survival of a nation, but the integrity of the European project, currently defended with arms by Ukraine and the Ukrainians, and the future credibility of international human rights protection.
