

2018-2020 STATE LEGISLATION ON MISSING AND MURDERED INDIGENOUS PEOPLES

STATE | BILLS | STATUS

ALASKA

Alaska Office of Victims' Rights

ARIZONA | HB 2570 | PASSED

Establish a study committee on MMIWG

CALIFORNIA | AB 1653 | HELD IN COMMITTEE

This bill would create the Missing or Murdered Indigenous Women Task Force in the Department of Justice, and would provide for the membership of that task force.

MINNESOTA | H.F. 70 | PASSED

Task Force on Missing and Murdered Indigenous Women created, annual report on issues related to violence against indigenous women and girls required, and money appropriated.

MONTANA | SB 312 | PASSED

A bill for an Act entitled: "An Act creating the looping in Native Communities Network Grant Program; Creating the Missing Indigenous Persons Task Force..."

@MMIWHOISMISSING

MONTANA | HB 21 | PASSED

An act establishing “Hannah’s Act”; authorizing the Department of Justice to assist with the investigation of all missing persons cases...”

MONTANA | HB 54 | PASSED

An act revising laws related to Missing Person reports; requiring all law enforcement authorities in the state to accept a report; providing exceptions.

NAVAJO NATION | N/A | N/A

Murdered Missing Diné Relatives Forum

NEBRASKA | LB 154 | PASSED

Directs the Nebraska State Patrol to collect data and produce a report on missing Native American women

NEW MEXICO | HB 278 | PASSED

Creating a Task force and declaring emergency on MMIWG

NORTH DAKOTA | HB 1313 | PASSED

An Act to amend and reenact section 54-12-34 of the North Dakota Century Code, relating to the collection of data on missing persons.

NORTH DAKOTA | HB 1311 | PASSED

AN ACT to amend and reenact subsection 2 of section 541233 of the North Dakota Century Code, relating to law enforcement training on missing and murdered indigenous people.

OKLAHOMA | INTERIM STUDY | PASSED

Interim Study on MMIW in Oklahoma

OREGON | HB 2625 | PASSED

The Department of State Police shall conduct a study to determine how to increase and improve state criminal justice protective, responsive and investigative resources and systems for reporting, identification, investigation and rapid response to future and past cases of missing and murdered Native American women in this state, including cases involving Indian country.

OSAGE NATION

Family Violence Prevention Department

SOUTH DAKOTA | SB 164 | PASSED

Provide uniform procedures for the reporting of and investigation of missing and murdered indigenous women.

UTAH | HB 116 | PASSED

Establishing MMIWG Task force

WASHINGTON | HB 2951 | PASSED

For State patrol to conduct a study to determine how to increase state criminal justice protective and investigative resources for reporting and identifying missing women in the state.

WASHINGTON | HB 1713 | PASSED

Create Two liaison positions for MMIW and persons establishing in Washington State Patrol with one in the western part of the state and other in the eastern region.
