**ADDITIONAL QUESTIONS:****1. Did the commodity distribution vary from your original plan (in terms of the number/location of beneficiaries, distribution partners, monitoring, etc.)? If so, how?**

There was no specific list of recipients, we have received multiple containers with similar inventory and we have more requests than inventory. We have been distributing goods on first come first serve basis

**2. Were the commodities of the quality and type that you anticipated? If not, please explain.**

In general, the container was well packed. We came across boxes with №100 in it was dirty and torn bedding linens. There was some inconsistency between packaging list and actual goods in the container. Carts for linen - 3 pieces instead of 6 pieces; Table Tool - 5 pieces, instead of 6 pieces; Bed functional - 2 pieces, instead of 3 pieces; Surgical tables - not in stock, according to the invoice of 1 piece; Pad for the office - is not included in the invoice 2 pieces; By the number of kilograms of a statement on the invoice weight of clothes is 2690 kg, and in fact found 1112 kilograms, according to the Act №003 / 15 dated 07/08/2015 about the discrepancy of the goods described in the packing list.
