### **ADDITIONAL QUESTIONS:**

1. **Did the commodity distribution vary from your original plan (in terms of the number/location of beneficiaries, distribution partners, monitoring, etc.)? If so, how?**  
*Due to changing regulations and according to the current Law of Ukraine "On humanitarian assistance" Article 6 ( states that the furniture is transmitted solely for use by the public health institutions, public organizations of disabled people), for this reason, distribution plan has been changed.*
  
2. **Were the commodities of the quality and type that you anticipated? If not, please explain.**  
*At opening and unloading containers we identified discrepancy in inventory. Number of furniture on the invoice did not match to actual numbers in containers:  
-beds in the amount of 65 pieces, instead of 79 pcs .;  
-Wardrobe in the amount of 22 pieces. instead of 58 pcs .;  
-Soft Chairs in the amount of 17 pieces. instead of 20 pcs .;  
-tables in the amount of 101 pieces. instead of 119 pcs .;  
-dressers in the amount of 48 pieces. instead of 57 pcs .;  
-chairs in the amount of 40 pieces. instead of 44 pieces.  
according to Act №001 / 16 dated 06.01.2016, the amount claimed for invoice 452 pcs, but in fact 368 pcs.*
  
3. **Other comments:**  
*Organizations on new list of distribution were carefully checked and were informed that this is donated humanitarian aid, it is being used to furnish temporary residence for current IDPs from areas touched by situation in Ukraine.*
