<p><b>Equipment</b></p>	<p>Customer's takes all responsibility for equipment while out of <b>Frezco's Property</b> and promises to return such equipment to Frezco in as good condition as it was at the effective date of the installation at customer's site.</p> <p>Natural wear from responsible use accepted. Frezco is not responsible for any water leakage from bottle or dispenser. Customers hold full responsibility for any water damage that may occur at customer's site. Proper handling of the Bottles must be taken during the insert of Bottle into the Dispenser.</p> <p style="text-align: center;"><b>PLEASE HANDLE THE BOTTLES WITH CARE</b></p>
<p><b>Equipment Rental &amp; Damages</b></p>	<p>Customer is responsible for return of all bottles. Customer shall be liable for any loss, damage or destruction of Frezco's property. Damaged dispenser will be charged to customer at \$350 per dispenser. Frezco will also charge \$25.00 per bottle for any damaged bottles. Frezco has the right to confiscate Its Property upon terminating this contract or if the customer fails to order regularly.</p> <p style="text-align: center;"><b>Customer is only Purchasing the Water &amp; The Equipment is the property of Frezco. There is No Monthly or Any Annual Rental</b></p>
<p><b>Attention</b></p>	<p><b>ALL EQUIPMENT IS FOR PRODUCT USE ONLY. THE USE OF ANY OTHER PRODUCT IN OUR BOTTLES OR DISPENSERS IS SUBJECT TO A CLEANING CHARGE. WE HOLD THE RIGHT TO CONFISCATE OUR BOTTLES AND EQUIPMENT AT ANY TIME IF MISS USED.</b></p> <p style="text-align: center;"><b>SUPPLY CONTRACT IS FOR A MINIMUM OF 3 YEARS</b></p> <p>NO DEPOSITS ARE REFUNDED IF CONTRACT IS TERMINATED BEFORE EXPIRY OF THIS CONTRACT. REFUND AFTER 3 YEARS IS ONLY FOR BOTTLES NOT FOR DISPENSER. 50% BOTTLE DEPOSIT ONLY REFUNDABLE AFTER USING FOR MORE THAN 6 MONTHS. THERE IS NO ADDITIONAL CHARGES AFTER 3 YEARS AND A NEW SUPPLY AGREEMENT SHALL AUTOMATICALLY BE RENEWED IF DISPENSER NOT RETURNED.</p>
<p><b>Water Delivery</b></p>	<p>Home &amp; Office delivery is weekly or on a prearranged schedule.</p>
<p><b>Payments Terms</b></p>	<p>Payments are to be made with 7 days from billing date to all Approved Credit Customers or You may also Pay COD upon delivery of water.</p> <p>All Credit Customers to also FILL UP THE CREDIT APPLICATION FORM and Credit Terms must be approved first before any credit is allowed.</p> <p style="text-align: center;"><b>PLEASE KEEP YOUR CASH SALES &amp; RECEIPT COPY ALL TIMES</b></p>
<p><b>Returned Cheques:</b></p>	<p>There will be a \$25.00 charge for returned cheques from Customers who pay by Cheque. Future cheques will not be accepted once cheque is returned.</p>
