

INGREDIENTS

- ½ cup mayonnaise
- Grated Zest of 1 Lemon
- 1 Tbsp Fresh Lemon Juice
- ½ bunch Chopped Fresh Chives
- 1-2 lbs Raw Shrimp, Peeled & Deveined
- Wafer Thin Prosciutto, Cut Into Appx 6 Pieces Per Slice
- Olive Oil, for Drizzling
- Black Pepper

_____ DIRECTIONS

- 1. Preheat oven to 400 degrees
- 2. Combine mayo, lemon zest, lemon juice, & chives in a bowl. Cover & Refrigerate
- 3. Wrap each shrimp in a small piece of prosciutto $\operatorname{\mathscr{C}}$ arrange on a baking sheet
- 4. Brush with olive oil & sprinkle with black pepper
- 5. Roast just until shrimp are done, about 6-7 mins



Meeting Minutes - March 19, 2024

- 2nd Read and Balloting: (6) Vickie Burback, Emily Arnold, Lanita Bunch, Marc Lamoreaux, Robert Oban and Melia Olsen
- Report of sick visiting committee: Tina Day's cancer has gotten worse so please keep her in your hearts. Also, Claire Fagan is facing a few procedures that should help her. Please pray for her.
- Reception and disposition of bills: Bills as of 3.19.24 totaled \$10,467.74. Signed off by two of the three of the finance committee. Motion was made to accept the bills as read, seconded and the motion passed.
- Communications: None
- Committee Reports: By-Laws have gone to Grand for approval and should take a couple of weeks for approval.
- Excuse of absentees: Linda Perez was not feeling well and unable to attend the meeting. A motion was made to accept Linda Perez's absentee, seconded and the motion passed.
- Unfinished business:
 - Kendall Jakes said the wood for the shelves is in and he is letting it acclimate to the room. It should be done in a couple of weeks.
 - Scott Nelson asked about the progress on getting rid of the wall in the kitchen. Jason Orahood said he
 has not received a response from the City, and he plans to meet with the Building Department in
 person. It is not known whether the wall was permitted.
- New business:
 - Jesse Carillo spoke about the rates on the Money Market account at Twin Star and First Security. He made a motion to take \$500 out of the Twin Star Money Market and to put in a checking account at First Security Bank. This would provide an increase in the rate of return on the Money Market. The motion was seconded and passed.
 - Jessie Carillo made a motion to take the money in the Money Market and checking accounts at Twin Star, close out the accounts and move those funds to First Security Bank in two CD accounts. Jesse stated that the Grand Aerie will have to approve this before this amount of money can be moved. The winnings of the #12 Pull Tab will be deposited into the First Security account going forward. The motion was seconded and passed with 16 in favor and 5 opposed.
- Trustee Report of finances: 3.12.2024 \$3419.06 was transferred to the Aerie. Motion was made to accept the Trustee's report as read, seconded and motion passed.

 earned about \$3300 for North Beach Medical. She stated she was proud of the Aerie for what they did
 the past weekend, and that it is benefitting a very worthy cause in our community.
 - Secretary Jason Orahood requested that the door to the meeting room be unlocked during the day so the room could be seen and used during the day. Blue Hummel said that had already been approved by the Trustees.
 - Jason Orahood recognized the volunteers who cooked the meal, washed the dishes and decorated the Aerie for the St. Patrick's Day event.

• Six Candidates: First Read Sally Klokkert and Brian Paprick

Report of sick visiting committee: There was not an update for this week. Tina Day passed on March 26, 2024. Cheryl
Turner also passed away. She was a member until May of 2022 and a big pillar of the community.

• Reception and disposition of bills: Bills as of 04.02.24 totaled \$16,372.35. Signed off by two of the three of the finance committee. Motion was made to accept the bills as read, seconded and the motion passed.

• Communications: The Washington State Eagle Newsletter is posted on the bulletin board.

Committee Reports

- The By-Law Committee reported that the Grand approved the changes with some suggestions as to how the changes needed to be reworded and formatted. They would like a copy of the Eagle Rider By-Laws & House Rules
 The Planning Committee has been postponed until next Wednesday at 5:00.
- Excuse of absentees: Scott Nelson and Alexis Stutsman were absent. A motion was made to accept Scott Nelson and Alexis Stutsman's absences, it was seconded, and the motion passed.

Unfinished business:

• Denise Charkow stated that Jason Orahood heard back from the Building Official at the City of Ocean Shores. The committee working on the kitchen will need to submit pictures, drawings and measurements of the wall that is to be taken out in the kitchen and call him when the work is completed. A permit is not needed. The building official may come to take a look at it. A permit is not needed to mitigate the black mold. The Aerie needs to make sure this is dealt with in a way that is safe for the members, volunteers and staff. Jason suggested looking into the option of leasing a dishwasher for the kitchen since the bar is leasing their dishwasher.

Jesse Carillo talked to Grand about the CD. A special meeting will be required before moving the \$125,000. All

members will be contacted by email or mail.

New business:

 Jill Janosec made a motion to give \$500 to the Sons of the American Revolution. They will be visiting Ocean Shores to help dedicate a bench at the Sand Dune Trail, presentations to honor veterans, they will be at the schools and at the library to help residents find relatives that are veterans. A motion was made, seconded and the

motion passed.

• Kendall Jakes made a motion to have Pizza Factory be able to deliver pizza during all the hours the Aerie was open for a 10% discount. This would be during the times the kitchen is open. The Aerie does not serve pizza. Their pizza oven is not usable. However, Pizza Factory offers a 10% discount to all Ocean Shores residents. A suggestion was made to go back to ask for a larger discount. The motion was changed to accepting Pizza Factory during all hours the Aerie was open. The motion was seconded. The motion did not pass.
