Mike Hill, request for leave to participate in the Firefighting Program out west again this year. Motion by Robert Stickner to grant request depending on actual dates when time arrives vs scheduled Township road projects. Seconded by William Taylor. Motion carried.

Secretary asked to contact Solicitor about issues with potholes being filled with concrete again after homeowner was already send a letter from the Township.

William Taylor made a motion to appoint Robert Stickner as Vice Chairman on the Supervisors Board to replace the position left open by Michael Hill. It was seconded by Robert Soltis. Motion carried.

A motion was made by William Taylor to provide \$10,000.00 from the ARPA funds to West County Paramedics for the sole purpose of purchasing a used ambulance. Discussion was had to the benefits of such a purchase. Motion was seconded by Robert Stickner. Motion carried.

A motion was made by William Taylor to participate with Harborcreek Consortium Program for seal coat. The amount would be 42,000 square yards. Seconded by Robert Stickner. Motion carried.

It was discussed to propose the sale of the roller to Springfield Township for 10,000.00 in kind. Details if accepted to be determined at a later date.
