Financial Report: The financial report was handed out with the agenda. Michael Hill made a motion to accept the report and to pay the bills as presented. This motion was seconded by Mr. Stickner. Roll call vote. All aye. Motion carried.

The remaining balance on the \$4k budgeted donation was \$1094.02 which will be donated to the Fire Dept by check. Michael Hill made a motion to accept the reallocation resolution and Robert Stickner seconded this motion. Roll call vote. All aye. Motion carried.

Resolution # 01620-5 stating the Township tax levy for 2020 was read and motion for approval by Michael Hill and seconded by Robert Stickner. Roll call vote. All aye. Motion carried.

The Chairman read and approved the dates for advertising the 2020 meetings. The secretary was told to place the advertisement.

Michael Hill made a motion to contract with the State for the 20/21 winter salt purchasing. The contract is due by March 15, 2020. Robert Stickner seconded. Discussion about pricing and savings followed. Roll call vote. All aye to contract with the State for salt. Motion carried.

The Board discussed the importance of dedicating an asset account for Capital Improvements and Michael Hill made a motion for the Township to invest up to \$200,000 into said fund with PLGIT Prime. Robert Stickner agreed and seconded the motion. Roll call vote. All aye. Motion carried.
