**Reports: Public Works** – Crew was cold patching and filling holes on dirt roads between snow and ice. Have received 350 ton of ODOT 411. Better for filling and packing in dirt.

**Planning** – Planning requested Supervisor input on project. Chairman suggested updating the Comprehensive Plan for the Township.

**West County Communications** – Board was determined. Bill Vassen is President. Wheelchair ramp needs repaired and board would like to rent space on tower for income.

The maintenance letters to Ivarea Road residents adjacent to the upcoming bridge replacement have been received and will allow the Township to work outside of the Right-of-Way to fix the dilapidated bridge this spring. The Edinboro Triathlon requested use of State and Crane Roads in the Township on June 6, 2020. Insurance bond was received. A letter of consent was signed by the Supervisors.

Resolution #20320-1 for revision to the Township's Sewage Facilities Act was reviewed by the Board and motioned for approval by Michael Hill and seconded by Robert Stickner. Roll call vote. All aye. Motion carried.
