

**Bloomdale Village Council
Meeting Minutes
October 11, 2022**

Opening

The regular meeting of The Bloomdale Village Council was called to order at 7:01PM by Bethany Vincent

Members Present

Jamie Robinson, Julie Dean, Bethany Vincent, Robert Clark, Kathy Simon and Tom Miller all answered roll call.

Bob Clark approved the minutes from the September 27th meeting and Tom Miller 2nd, all approved.

9-R-22 was read for the park grant application by Bethany Vincent. Bob Clark made a motion to suspend the rules and Kathy Simon 2nd, all approved. Bob Clark moved to accept it and Julie Dean 2nd, all approved

13-O-22 an ordinance to amend salary of council members was read by Bethany Vincent in a 2nd reading.

14-O-22 an ordinance amending the salary of the Mayor of Bloomdale was read in a 2nd reading by Bethany Vincent.

Billy Mareches batteries that we approved last meeting are picked up and installed from Casey's. The bill should be about \$480.

The remote monitor that we purchased for the grass rig, the best he can narrow it down is \$500 for the fittings, piping, etc. The department will purchase it and turn in a bill for reimbursement. Bethany Vincent made a motion for the \$500 and Bob Clark 2nd, all approved.

610 is now back and 615 needs to get to Class 8 for brakes. There's no estimate. Bob Clark made a motion for the brake repair and Kathy Simon 2nd, all approved.

Last meeting, he mentioned the power cot. He was going to talk to the trustees about getting one in one of the squads we still have. It doesn't sound like it'll happen. He's going to try to get one on a grant next year. He's still going to work on the trustees though.

EMS wise, today he turned on an auto aid pager tone so when there's an EMS run, Perry Twp. and Cygnet would be alerted and would go where they were

going. Today he shut it off because medical direction from Cygnet hasn't been helpful. Perry Twp. isn't participating in mutual aid either.

Bob Clark will be the representative for the joint ambulance district board.

Rob Fawcett, insurance agent was here to introduce himself and discuss the Village's policy

Council went into executive session at 8:10AM to discuss legal action. Bob Clark made the motion and Julie Dean 2nd, all approved.

Bob Clark moved to exit executive session, no action taken at 8:30PM and Tom Miller 2nd all approved.

Government Accounting Solutions bill for a license renewal and software support for utility bills. \$2,000. Bob Clark made the motion and Julie Dean 2nd, all approved.

Discussion about the streetlights.

The ballpark lights grant.

Jamie Robinson got a quote for the PEP grant, and it comes out to \$820.

The painting of the water tower. Bethany Vincent reached out to NW Water & Sewer. Jerry Griner told her that he'd talk with Tom. That was on 10/04/22.

Bob Clark asked a question about the police cruiser running all day.

Bob Clark made a motion to pay the bills and Bethany Vincent 2nd, all approved.
