### A RESOLUTION TO ACCEPT AND ADOPT THE FOLLOWING AS A GUIDE TO THE RENTAL FEE SCHEDULE FOR THE RENTAL OF THE COMMUNITY BUILDING, VILLAGE OF BLOOMDALE, WOOD COUNTY, OHIO.

#### **SECTION I:**

##### **(a) Rental Fees:**

Monday – Thursday: \$100.00

Friday, Saturday, and Sunday: \$200.00

##### **(b) Booking:**

\$100 deposit to be collected at the time of booking will be refunded by the Fiscal Officer-Clerk after each event. The deposit is forfeited if the Village has to pay for cleaning or if damages must be repaired.

Note: The leasee will be responsible for any cost over this deposit.

Rental fees will be paid before keys are given. All monies collected will be given to the Fiscal Officer-Clerk within 24-hours. Leasee must sign contract accepting full responsibility for the Community Building and alcohol.

**SECTION II:** All resolutions or parts of resolutions in conflict with this resolution shall be hereby repealed, specifically Resolution 3-R-16, adopted August 23, 2016 and Resolution 2-R-12, adopted March 13, 2012.

**SECTION III:** It is hereby found and determined that all formal actions of Council concerning and relating to the adoption of this Resolution were adopted at an open meeting and deliberations of Council and any of its Committees that resulted in such formal action were in compliance with all legal requirements.

**WHEREFORE**, this Ordinance shall take and be in full force immediately upon its passage and approval.

A Resolution to accept and adopt the following as a guide to rent and maintain the Bloomdale Community Building:

Rental Fees

Friday \$150.00 -  
8am - 1am

Friday - \$250.00 from 4:00 p.m. until 1:00 a.m. and an additional \$50.00 per hour after 1:00 a.m.;

Saturday - \$300.00 from 4:00 p.m. until 1:00 a.m. and an additional \$50.00 per hour after 1:00 a.m.;

Sunday to Thursday - \$100.00 after 4:00 p.m.;

For any rental prior to 4:00 p.m., for a two (2) hour period, on any day - \$50.00. (The building must be completely cleaned by the renter.)

In return for hours of labor B.F.D. accrued in the building no fee will be required for their annual banquet provided they reach the date six (6) months in advance and clean after the event. *active personnel*

Any resident of the Village of Bloomdale who presents to the Village verification of residency and is current on his/her electric bill will receive a \$50.00 discount any Friday or Saturday rental.

Booking

\$100.00 deposit at the time of booking will be refunded by the Clerk ~~within one (1) week~~ after each event. The deposit may be forfeited if the Village has to hire people to clean the room or if damages need to be repaired.

Note: The lease will be responsible for any cost over this deposit.

Cost of rental will be paid before keys are given. All monies collected will be given to the Clerk within 24 hours. Lessee must sign contract accepting full responsibility for building and alcohol.
