

Ordinance 2024-O - 07

AN ORDINANCE REQUESTING THE OHIO DEPARTMENT OF TRANSPORTATION TO ESTABLISH SPEED LIMITS ON STATE ROUTE 18 WITHIN THE VILLAGE OF BLOOMDALE AND DECLARING AN EMERGENCY.

WHEREAS, the Village currently has a portion of State Route 18 within its territorial boundaries for which safe speed limits need to be established; and

WHEREAS, Section 4511.21 of the Ohio Revised Code permits local authorities to authorize prima facie speed limits different than those contained in said section subject to the declaration of the Ohio Department of Transportation provided that the same does not exceed fifty (50) miles per hour; and

WHEREAS, the Village has completed a traffic study for the purpose of determining safe and reasonable speed limits on those portions of State Route 18 within the Village; and

WHEREAS said traffic study indicates that safe and reasonable speed limits be established on State Route 18, which vary from the statutory speed limits; a copy of which is attached hereto as "Exhibit A"

NOW, THEREFORE be it Ordained by the Council of the Village of Bloomdale Ohio:

Section 1. The Director of the Ohio Department of Transportation is hereby requested to establish safe speed limits on State Route 18 within the Village of Bloomdale which comport with the recommendations set-forth in Exhibit A.

Section 2 This Ordinance is being passed as an emergency necessary to protect the public health safety and well being as well as that of the motoring public

Section 3 Copies of this Ordinance were posted the most public places in the Village, as determined by Council, for the period required by law.

Section 4 That this Ordinance shall take effect and be in full force and effect immediately upon its passage providing it receives a vote of two thirds of all members elected to Council; otherwise it shall take effect and be in full force from and after the earliest period allowed by law.

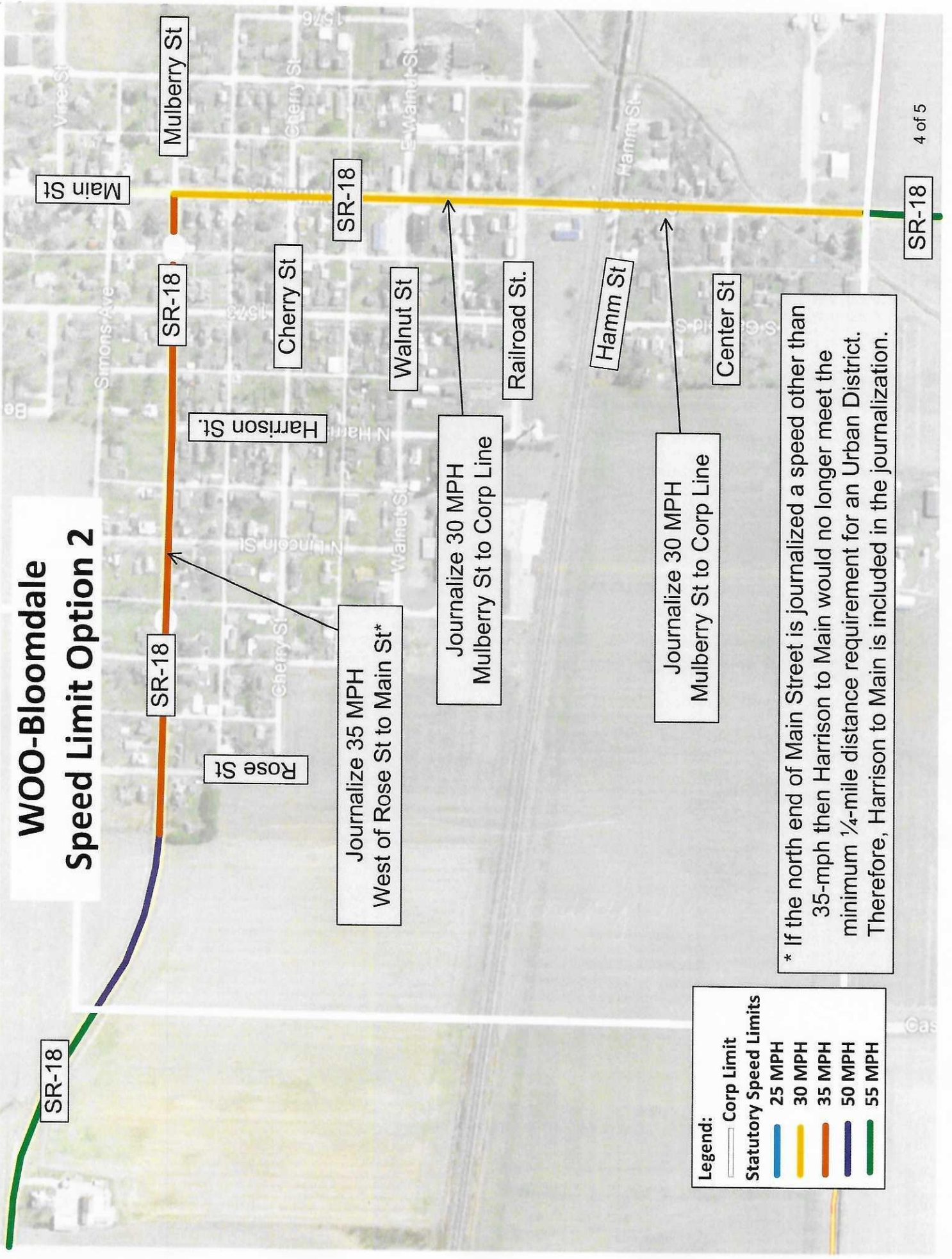

* If the north end of Main Street is journalized a speed other than 35-mph then Harrison to Main would no longer meet the minimum 1/4-mile distance requirement for an Urban District. Therefore, Harrison to Main is included in the journalization.
