## NEW SERVICE HOOKUPS, CONNECTION FEES, SECURITY DEPOSITS & DELIQUENT ACCOUNTS FOR RENTAL PROPERTIES

Any new electric service hookup to a new or existing building shall be assessed the following:

- 1. Residential (Owner Occupied, Single Family): \$300.00 Installation Fee
- 2. Rental or Multi-Family: all new electric service will be charged at the current rate for time, materials and wages at the time of hookup as set forth by the Village Administrator.

An Electric service connection for ALL customers shall be assessed as follow:

1. All new customers requesting service in the Village shall be required to pay a connection fee of \$50.00 to which is Non-Refundable

## Security Deposits:

- 1. A \$250.00 Security Deposit shall be required of all new customers requesting electrical service.
- 2. Any late Payments during the first year will result in forfeiture of the security deposit. The security deposit is refundable to the customer after the first year (12 months) of on-time payments.
- 3. If the customer moves within the first year of residence and his/her account is in good standing, and the customer has never had a late payment the \$250.00 deposit (less any amount due owing) shall be refunded to the customer.

Delinquent Accounts Shall Be Addressed By the Village Administrator As Follows:

- 1. Any Payment after the 20<sup>th</sup> of the month shall be assessed a 10% late charge.
- 2. Any payment that is 60 days late shall continue to be assessed a 10% late charge on the amount due (not cumulative) and will receive a 30 day disconnect notice. To prevent disconnection the customer must pay, including late charges, the account in full, including recent charges.
- 3. Those accounts that are 90 days late may have the meter pulled (Service Disconnected). To reestablish service, the customer must pay the account including accumulated late charges in full to current billing cycle, plus a \$50.00 reconnect charge.

The Security Deposit of slow paying customers (as determined by the Village Administrator) will be applied to the utility bill when service is terminated.
