Parent(s)/Guardian(s).

1. **Parent(s)/Guardian(s)** do hereby enroll their child, _____, into The Whitestone Academy, a private, non-sectarian, co-educational secondary school for the academic school year.
2. **Parent(s)/Guardian(s)** agree to pay the total tuition amount of \$7920.00 according to the following payment options: (kindly check your preference)

An initial payment of \$880.00 to be paid, and eight monthly installments thereafter of \$880.00 beginning and due on the 1st day of each month thereafter until paid in full.

3. All payments shall be made payable to the Whitestone Academy.
4. In the event that **Parent/Guardian** is more than ten (10) days late on any payment, the **Parent/guardian** agrees to pay 5% of the installment due as a late fee.
5. In the event that **Parent/Guardian** is more than 30 days in default of any installment payment, the **Parent/Guardian** agrees to pay for all late fees owing, interest at 8% per annum, costs, filing fees, and attorney fees related to any collection required to obtain payment.
6. The **Parent/Guardian** agrees and acknowledges that full tuition is due and owing in the event that the student fails to complete the entire school year. Also, in the event a student is expelled, tuition is not refundable.
7. For students to continue their studies in school, and to take final examinations and receive report cards or have records transmitted, regular payments must be made. Where accounts are in arrears more than 30 days, the board may require withdrawal unless satisfactory arrangements are made.
8. If any provision of this agreement or the application of any provision of this agreement is held invalid, the remainder of this agreement and the application of such provision other than to the extent it is held invalid will not be invalidated or affected thereby.
9. This agreement will be binding upon and inure to the benefit of the legal representatives, heirs, executors, and administrators of the parties hereto.
10. This agreement will be governed and construed in accordance with the laws of the state of New York.
