## Food Truck Application

On Saturday, September 28<sup>th</sup> at *Vista Park* in Pine Beach, the Pine Beach Fire Company, No. 1, with the assistance of the Pine Beach Yacht Club, presents *Fire Fest VIII*, a fundraiser that will be open to our community and to the general public. It will run from 12 noon to 7 pm, offering crafters/community organizations and services, food trucks, a beer/wine garden, bounce house and other activities for children, as well as demonstrations of fire safety and rescue operations. Running concurrent with the usual FireFest Activities will be a car show. This year's musical entertainment will again be provided by the *Drunken Clams*.

To reserve your space, the form should be completed and returned with the \$100 application fee no later than <u>July 1<sup>st</sup></u>. If there is space available after this date vendors will pay a fee of \$125 to register.

**Event is rain or shine.** If the event is held, all fees are non-refundable donations to the Pine Beach Fire Co.

## **Event Rules**

- Vendor may not break down their operation until 6:30 pm. Canopies and Umbrellas are encouraged. **Small generators permitted.**
- Trash removal, including packaging, is vendor's responsibility. Windy conditions may necessitate
  weights for canopies, please plan accordingly. Pets as guests are not prohibited at this event.
   NOTE: INDIVIDUAL FOOD VENDOR LOCATIONS WILL BE ASSIGNED ACCORDING TO
  THE DATE THE APPLICATION IS RECEIVED
- A New Jersey Tax ID may be required. If you do not have a tax number, please contact the New Jersey Division of Taxation CIS, CN 252 Trenton NJ 08646, 1800-323-4400. The festival sponsors assume no responsibility for the tax obligation of our vendors.
- Appropriate Department of Health Certificates must be available for inspection on site on the day of event.
- The State Fire Marshal requires Each Food Truck Participating to have a *Type 11 1L12 Permit*. Permit applications to the State Fire Marshal must be submitted at least two weeks prior to the event to ensure an inspector can be assigned.
- Set up start time: **10:00 AM**, Event officially begins at **12 noon**.
- Vendor may not break down truck until **6:30pm**. As the sun is beginning to set by the conclusion of the event, lighting towers will be in place for the benefit and safety of our vendors and staff
