Please read this letter carefully and then sign it. Your signature means that you agree with the letter's contents. Please sign two copies of this letter. One for you to keep and one for me to keep.

This fee scale details our fees for all immigration advice and services that we are registered to provide to our clients. We normally charge on a fixed fee basis.

Please note that our organisation is not VAT registered. Therefore, no VAT will be added to the fees outlined below. The fixed fees include: all attendances and written and telephone correspondence with you and relevant 3rd parties; consideration, preparation and submission of application and relevant supporting documents. Copies of documents and postage.

Fee Structure

We are happy to discuss with you whether you need legal advice or representation and what steps we could carry out on your behalf. This fee scale details our average fees for immigration advice and services that we are registered to provide to our clients. We generally charge on a fixed fee basis. This means you will know before we begin to work on your case, what our charges will be, and these will not change, unless there is a change of circumstances in your case and the nature of work.

Face to face one off advice appointments are also available to enable you to obtain initial advice and then take a decision as to how you wish to proceed and whether you wish us to act for you. One off advice appointments normally take between 1 - 1.5 hours.

Full instructions will be taken from you after the initial appointment and we will then advise you as to the range of options available to you. This advice will then be confirmed fully in writing so that you have a reference document upon which you can base your decisionmaking.

Note that the fees quoted below are our professional fees and do not include any fees charged by the UK authorities to lodge an application (in the UK or overseas) or court fees. These would be advised according to the required service.

The fees do not include disbursements that may be required such as interpreter and translation costs, expert reports and unusual travel expenses. Disbursements are charged at cost and paid by you directly.

Three-stage Payment

- 1. At the initial meeting £100 is due to be paid. This is non-refundable.
- 2. We then send you a client care letter detailing your instructions and what we would suggest doing as well as your success chances. This must be signed if you would like us to proceed with your instructions. After submitting your application to the Home Office 50% of the remainder of the fee is due to be paid. This is non-refundable. *
- 3. Upon receiving a positive decision from the Home Office, the remainder of the fee is due to be paid. This is non-refundable. **

This way, you are entitled to decide upon every stage whether to proceed or not.

For example:

The fee an Indefinite Leave to Remain is £500.

At the initial meeting you pay £100.

After submitting your application to the Home Office, you pay another £200.

When you have finally received your Indefinite Leave to Remain you pay the remaining £200.

Payment is accepted by bank transfer, cheque, direct debit, cash and all major debit & credit cards.

PLEASE NOTE:

- * If within 3 months from the date of the client care letter we cannot proceed due to not being provided by you enough information and documents, where you could have reasonably provided them within the 3 months' timeframe, the three-stage payment cycles goes back to stage 1. So, if you will be still willing for us to proceed with your case, you will have to pay the initial £100 again.
- **Failure to follow my instructions to you will mean that you will have to pay 100% of the remainder of the fee even before the completion of your application, regardless of its results.
