E. USE OF DOG

Buyer agrees this dog is a **working breed**, intended for any of the following: breeding (with proper testing), companionship, protection, service, therapy, herding, carting, search and rescue, AKC sports or conformation. Buyer agrees NOT to:

- Breed a limited registration dog
- Use this dog for illegal purposes, fighting, or unsupervised attack training
- Rehome, resell, or transfer without Breeder's written consent
- Leave the dog chained or in unsafe/unattended conditions

Violations void the contract. The dog must be returned to Breeder if proof of violation is provided. No refund will be issued.

F. VACCINATIONS & VETERINARY CHECK

- Puppy is in excellent health with age-appropriate vaccinations and deworming.
- Buyer must complete a licensed vet exam (physical + stool test) within **72 hours** of pickup. All vet costs are Buyer's responsibility.

If a serious genetic issue is found:

- Provide a written vet statement within 72 hours.
- Breeder's vet will review.
- If confirmed, a replacement credit will be issued (no refund).
- Puppy must be returned with paperwork/supplies.

Euthanasia Clause: Must notify Breeder at least 24 hours before euthanasia for guarantee to remain valid. Vet must release records to Breeder.

Proof of Care:

- Buyer must provide proof of initial exam within 72 hours
- Must retain and provide original shot record (with litter info & microchip number)
- Must provide full lifetime vet records for any replacement consideration

Exclusions: No coverage for:

- Parvo beyond 5 days post-pickup
- Giardia, Coccidia, Kennel Cough (unless diagnosed within 72 hours)
- Accidents, trauma, or conditions mimicking genetic issues

G. AKC & AKC REUNITE REGISTRATIONS

AKC Registration:

- Puppy qualifies for AKC registration; papers guaranteed within 12 months
- Registered name must begin with "84GotRotts" (failure voids contract)
- Ownership transfer to be completed within 60 days of receiving papers
- Only AKC or Canadian Kennel Club registration allowed

Microchip Requirement:

- Must be registered with AKC Reunite
- If not already chipped, Buyer must chip within 60 days and submit details to Breeder
- Failure to comply voids this contract.

H. JOINT DYSPLASIA AND CONGENITAL HEALTH GUARANTEE

H1. Joint Dysplasia Guarantee

- Guaranteed free from "moderate/severe" dysplasia through age 24 months
- For show/breeding dogs: minimum Orthopedic Foundation for Animals (OFA) rating of "Fair"

To make a claim:

X-rays required at 12 months and 24 months

- If 12-month X-ray shows dysplastic signs, recheck by different vet in 6–8 months and submit to Orthopedic Foundation for Animals (OFA)
- If 24-month X-ray fails, 3-month window allowed for resubmission
- If OFA downgrade from prelim of "Good/Excellent" to sub-"Mild" rating will be considered environmental

Prevention Required:

- Feed 3–5 star food (per <u>www.dogfoodadvisor.com</u>), avoid foods with corn and by-product in first two ingredients
- Avoid over/under-exercise, excess jumping, and obesity
- Follow all feeding guidelines recommended by the Breeder
- Failure to comply voids coverage.

H2. Congenital Health Guarantee

Covers death or necessary euthanasia due to congenital defects: major heart defects, organ failure, joint dysplasia, etc. To qualify:

- Provide the veterinarian diagnosis in writing
- Breeder notified and provides response before euthanasia
- Breeder may request a second opinion
- Autopsy required (Buyer's expense)
- Buyer must submit full medical report (no abuse or neglect)

Exclusions (Not Covered):

- Cosmetic or correctable conditions: cherry eye, umbilical hernia, entropion, mild heart murmurs
- Parasitic or stress-related illness (e.g., Giardia, Coccidia)
- Cancer not covered, though immunity support is recommended
- Accidents or injuries

Replacement Puppy Terms:

- Requires full compliance with all care conditions
- Must provide full vet history
- Must have used <u>NuVet Plus®</u> and <u>Life's Abundance</u> products daily
- Lifetime guarantee applies with documented daily use of both products
- No vet costs are covered by Breeder under any circumstances.

 - Breeder retains first right of refusal and will accept return at no cost
 - Breeder may reclaim the dog in cases of neglect (no refund)
 - Unauthorized rehoming gives Breeder right to recover full purchase price and court costs
- J2. Right of Replacement (Health Guarantee Fulfillment)
 - Buyer must provide proof of spay/neuter (unless deceased)
 - Written vet documentation and microchip # required
 - Replacement offered at 80% off current puppy price
 - Same sex/value puppy unless otherwise agreed
 - No refunds after 72-hour pickup window
 - Valid for 2 years from claim date

K. PET QUALITY REQUIREMENTS: TEMPERAMENT, SPAY/NEUTER, TRAINING

120-Day Temperament Guarantee:

- Buyer covers all transport costs; AKC paperwork must be returned

Spay/Neuter:

- Spay/neuter by 24 months required for pet homes
- No breeding of limited registration dogs
- Exceptions must be pre-approved in writing

Socialization & Training:

- Gradual exposure post-vaccination to people, dogs, and new environments
- Enroll in obedience class by 12 months
- Provide proper nutrition, vet care, exercise, shelter

- AKC (or ADRK/UKC/CKC) registration complete
- Hips, elbows, heart, eyes cleared via OFA, PennHIP, or equivalent
- Dog must be 24+ months

Breeder Stud Rights:

- Breeder may request to breed a program female to Buyer's stud at pre-agreed terms
- Buyer agrees to sign AKC litter registration
- Breeder covers transport/collection fees
