E. STUD SERVICE CONTRACT REQUIREMENTS

Intl. _____

1. The female must pass an American or foreign orthopedic Hip exam with excellent or good and elbow normal, grade I or II Certification (suitable for breeding) before the AKC litter registration will be accepted.
 - a. If the female in this contract **AKC#** _____ does not have a valid, passing OFA hip or elbow grade suitable for breeding, or the female is not OFA certified, the stud owner will deny the litter registration application by phone, online request or paper mail in request.
 - b. If after mating but before litter registration is approved, the female is found to have any hereditary diseases, the AKC litter registration application will be denied. AKC rules and guidelines are available by contacting the AKC at (919) 233-9767. AKC rulebook <http://images.akc.org/pdf/rulebooks/RREGS4.pdf>, chapter 3
2. The female must be free of any disqualifying show faults or hereditary diseases.
3. A picture of the female will be taken to add to the copy of my stud contract.
4. Veterinarian certification of health and breeding soundness of the female, including: **deworming, all current vaccinations, negative brucellosis and negative for vaginal infections.** All test results MUST accompany female.

F. STUD SERVICE PROCESS

Intl. _____

1. Breeder/Seller certifies that the dog has been registered under the Regulations of the [American Kennel Club \(AKC\)](#) as a purebred Rottweiler and will provide the proper forms for transfer of ownership of this registration. In some cases, registration can take time to finalize, seller has up to 12 months to deliver registration to the buyer and guarantees buyer will get registration papers.
2. Two natural breedings will be attempted. There are no boarding charges for a stay of 10 days or less. After 10 days, a ten dollar (\$10) per day fee will be applied.
3. The buyer certifies that this female has not been exposed to any other stud dog prior to her arrival and that she will be protected from exposure after she leaves the breeder facility. **If the female is exposed to another male and a mating takes place, the owner of the female is responsible for the balance of the stud fee and registration papers will not be signed.**
4. Should the female fail to whelp at least one puppy, one additional stud service will be available during the female's next heat season, provided ownership of the female and the stud dog has not been transferred. If NO pregnancy results from the return mating, this agreement is terminated. **No stud fee will be refunded, in whole or in part.**
5. In the event of a return breeding due to conditions listed in list item 4 above, if the stud dog dies or is not available, the stud dog owner will offer another stud dog of equal breeding value and age. If the buyer refuses the stud dog offer, this entire agreement is terminated.
