

Zenith Maine Coons Wait List and Reservation Fee Agreement

We offer our kittens to families in order of received application and reservation fee.

Our Policy:

- **First fee received gets first choice and so on. Holding fees can be accepted in the form of cash, Venmo @ZenithMaineCoons, or a cashiers check.**
- **The amount of deposit required is \$200. (* Specific terms apply.) This deposit goes toward the final purchase price of the kitten.**
- **Buyer is given up to ten weeks to decide what kitten to reserve from pairing that is chosen by the buyer. 10 weeks is a good time to do picks so Buyer and Breeder can assess personalities and sex the kitten appropriately. If no kitten is picked, then you will have the option to move the deposit to two future litters.**
- **Kitten MUST be paid in full by the time the kitten leaves our cattery.**
- **Seller will meet with Buyer via live video chat and/or photos to help choose their kitten by 10 weeks of age. Buyer has 24 hours to choose which kitten they want after video chat and/or photos. This prevents holding up other families in line.**

*** If a kitten is not chosen within a 12 month period, the deposit of \$200 is refunded.**

**** By submitting my waitlist holding fee to Brittney Lott of Zenith Maine Coon Cattery, I confirm the following:**

- **I understand that if I have refused all offered kittens from the three litters, my deposit may be returned at the Breeder's discretion. If a kitten is not picked within a 12 month period my deposit is automatically refunded.**
- **I understand that I will need to pick my kitten from a live video chat and/or videos and photos that are provided.**
- **I understand that if I neglect to respond to Zenith Maine Coon's correspondence about a kitten being offered to me within 24 hours, then she will move on to the next in line.**
- **I understand that I must take possession of the kitten by the date approved by the breeder (14-15 weeks). If I am to delay in pickup of the kitten by more than one week, I may have to pay an additional fee of \$10 per day for boarding.**
- **I understand that the balance needs to be paid in full by the time the kitten is picked up.**

- I understand that Breeder reserves the right to terminate this contract and return deposit at any time and for any reason.
- I understand that the kitten is not being sold with breeding rights and will be altered at 12 weeks of age, or SpaySecure agreement must be initiated.
