Waiver and Release from Liability

In consideration of entry into canine training and obedience classes, and any related events and activities (use of facilities and/or property, participating in classes, off-site training) offered by PAWSitive Training llc (hereinafter "PAWS"), a Wyoming limited liability company, and intending to be legally bound, the undersigned ("participant"):

1. Acknowledges that canine training occurs primarily in the context of group classes and PAWS does not guarantee the temperament of the other canines in the class or which may be present at the PAWS training facility.
2. Acknowledges receipt, has read and accepts Class Operating Policies.
3. Acknowledges and fully understand that each participant will be engaging in activities that involve risk of injury, which might result not only from their own actions, but inactions or negligence of others, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to PAWS or not reasonably foreseeable at this time.
4. Acknowledges that PAWS is not able to guarantee the treatment of a canine and completion of a canine training class is no guarantee of the future temperament of a canine.
5. Assumes all foregoing risks and accepts personal responsibility for the conduct of participant's canine both during class and at all other times, irrespective of the training and obedience instruction offered by PAWS.
6. Release, waive, discharge and covenant not to sue PAWS, Susan and/or Michael Hoy, their affiliated organizations, their respective administrators, directors, agents, instructors, teachers, employees, presenters, sponsoring agencies, the owners and lessors of premises used to conduct the all aforementioned canine training and obedience classes, and any related events and activities, all of whom are hereinafter referred to as "releasees" from demands, losses or damages on account of bodily injury or property damage, caused or alleged to be caused in whole or part by negligence or the releasees or otherwise.
7. Acknowledges that all vaccines that are required for their pets are current and is aware that other communicable illnesses may affect a pet and participant. Owner/Participant acknowledges and agrees that they are assuming all risk of illness, disease, harm or otherwise to their pet and themselves by allowing their pet and themselves to participate in activities with PAWS.
8. No credit /refund for classes missed unless prior notice – one class can be made up. No credit/refunds after 2nd class
