

84 Afghan servicemen were detained while crossing the Uzbek border. The Afghan servicemen were seeking medical help, which the Uzbek side provided. Similarly, the Afghan troops on the Termez-Khairaton bridge were given humanitarian aid.

Uzbekistan Declining Afghan Visa Requests, Warns Illegal Crossings 'Harshly Suppressed'

An Afghan combat plane, while illegally crossing the border, was taken down by Uzbekistan's air defense system. Also, 46 Afghan aircrafts were forced to land after entering Uzbekistan. 22 military planes and 24 helicopters, carrying 585 Afghan soldiers, were forced to land after flying into Uzbek territory.

158 Afghan military men crossed the border on foot. To manage the refugee inflow, Uzbekistan has stopped giving visas to all Afghan citizens.

5. ECONOMIC OVERVIEW

5.1 LOCAL LEVEL

Uzbekistan's gold and foreign exchange reserves up by USD 1 billion

The nation's gold and foreign exchange reserves grew from USD 34.1 billion to USD 35.1 billion. The increase was caused by the resumption of gold prices on world markets.

The GDP for the first 6 months of 2021 grew by 6.2%, and inflation slowed down despite the rising prices for consumer goods. Investments from non-centralized sources increased by 14.39%, while government loans and financing decreased by more than 36%.

In addition, as part of IsDB's post-pandemic economic recovery initiative, Uzbekistan received USD 200 million for the development of its rural areas.
