The dialogue between EU and Uzbekistan intensified in July on vario levels:

- On the 4th of July Charles Michel spoke with Uzbekistan's President Shavkat Mirziyoev.
- Large German (Ost-Ausschuss der Deutschen Wirtschaft) and French (MEDEF) business delegations visited Tashkent in early July.
- Uzbekistan's Deputy Prime Minister Minister for Investments & Foreign Trade visited to Brussels to meet with the European Commission and witness the initialling the text of negotiated Enhanced Cooperation and Partnership Agreement (EPCA),
- Uzbekistan's Deputy Prime Minister Minister for Investments & Foreign Trade visited London to meet with Europe's think-tanks and with the President of EBRD, H.E. Odile Renaud-Basso.
- EU and Uzbekistan have announced the dates for the EU-Central Asia connectivity conference to be held in Samarkand on November 18-19<sup>th</sup> 2022.

### UN approves a special resolution on Central and South Asia initiated by Uzbekistan

On the 11th of July, the UN General Assembly unanimously approved the special resolution on strengthening the interdependence between Central and South Asia developed by Uzbekistan under the co-sponsorship of 40 countries.

#### Tashkent hosts international conference on Afghanistan

On July 25-26, Tashkent hosted an international conference on Afghanistan. The Taliban was present for the first time, along with special representatives on Afghanistan from 20 countries, including European Union Special Envoy for Afghanistan Tomas Niklasson.

#### Tashkent hosts a meeting of the Council of Foreign Ministers of the Shanghai Cooperation Organization (SCO) member states

A meeting of foreign minister's that took place on July 28-29 paved the way towards SCO Leaders Summit to take place in Samarkand on September 15-16, 2022

### Karakalpakstan protests

After 2 days of social unrest in Uzbekistan's westernmost region (1-2 of July), the situation in Karakalpakstan returned to normal. Protests had erupted after the proposed amendments to the constitution that would have reduced the region's autonomy were published. The proposals were scrapped by the President after the protests erupted. According to the official data, about 20 people were killed, with four out of them, law enforcement officers. 274 civilians and 141 law enforcement personnel were wounded.. The riots caused 3 billion 147 million soums (approx. 286 thousand USD) of damage. The state of emergency introduced in the region on the second day of the protests was lifted on 20th of July

### Parliamentary commission to investigates the events in Karakalpakstan

On the 15th of July, a joint Parliament's commission headed by the Ombudsman Feruza Eshmatova was established and started its independent investigation in Karakalpakstan. The commission includes representatives of the Oliy Majlis and people's deputies, heads and employees of non-governmental, non-commercial and public organizations. The list of commission members was not disclosed in the official report.

Due to the decree, cooperation between regional departments of the Ministry of Innovative Development and deputy khokims of relevant districts on innovative development issues will be established.

### Government sets up «Virtual Business Office» portal

According to the presidential decree, the unified interactive portal "business.gov.uz" will be transformed into the information portal "Virtual Business Office".

### The practice of delivering a citizen to the internal affairs department for identification is revoked

According to the resolution, from 1 January 2023, the E-patrol system will be gradually introduced, and the practice of bringing a citizen to the police department to establish his identity will be cancelled.

### Uzbekistan added to list of transit countries of export control evasion attempts for sanctioned goods

The US Department of the Treasury has added Uzbekistan to the list of countries through which sub-sanctioned goods can enter Russia and Belarus. FinCEN and BIS agencies urge financial institutions to "be vigilant against attempts by individuals or entities to evade export controls" imposed because of the Russian invasion of Ukraine.

Uzbekistan-EU relations have completed a milestone on the 5th of June 2022, as the negotiations on the Enhanced Cooperation & Partnership Agreement (EPCA) between the two sides have been completed after the four vears of intensive discussions. The final text was initialled in Brussels, witnessed by Uzbekistan 's Deputy Prime Minister, Minister of Investments & Trade, Sardor Umurzakov & Head of Cabinet for EU's High Representative for Foreign & Security Policy, Pedro Serrano. The agreement contains political, social, economic and security co-operation chapters, which will reinforce the bilateral partnership, increase Uzbekistan's investment potential and attractiveness, facilitate opportunities for economic growth, and boost Uzbek resilience. The Agreement draft will now make its way through EU and Uzbekistan's official institutions for final approval and endorsement before it is ready to be signed. Learn more

Besides the participation of the EU High Representative for Foreign Affairs and Security Policy Josep Borrell and the EU Commissioner for International Partnership Jutta Urpilainen as well as the representatives of the five Central Asian governments and the EU, private sector representatives will also take part in the discussions. The conference will address three main topics: improving digital connectivity, transport network development, water and energy issues.









Figure 5 Total cases for July 30: 243.000 Deaths: 1,637




