NOTABLE EVENTS PAST MONTH

Uzbek President Shavkat Mlrziyoev paid a v Arabia on August 17-18, 2022

visit to Saudi

It was the first trip by an Uzbek president to Saudi Arabia in 30 years :

• Uzbekistan and Saudi Arabia signed 15 agreements and contracts worth USD 14 billion. Agreements were reached in energy, chemical, electrical engineering, infrastructure development, agriculture, pharmaceuticals, information technology and transport.

• Saudi utility developer ACWA Power signed an agreement valued at around USD 2.4 billion to build a 1500MW wind project in Uzbekistan, which would be the biggest single-site onshore wind project in the region and is expected to power 1.65 million households and offset 2.4 million tonnes of carbon emissions per year.

• Shavkat Mirziyoyev held talks with the President of the Islamic Development Bank (IDB) Muhammad bin Sulaiman Al Jasser, securing USD1.6 billion IDB funding for projects in Uzbekistan.

• Uzbekistan introduced visa-free regime for Saudi Arabian citizens for 30 days, while the King of Saudi Arabia was awarded the Order "Oliy Darajali Imom Bukhoriy".

Twitter, Vkontakte and WeChat unblocked in Uzbekistan

Uzbekistan lifted restrictions on the operation of social networks Twitter, Vkontakte and the WeChat messenger, while negotiations with TikTok are still ongoing.

Uzbekistan, Turkey and Azerbaijan held tripartite talks for the first time

For the first time in Tashkent, the ministers of foreign affairs, trade and transport of Uzbekistan, Turkey, and Azerbaijan held tripartite talks. As a result of the meeting, the Tashkent Declaration was signed, which absorbed all the agreements on the sidelines of the Forum such as creating a new e-commerce platform, double the volume of trade, formation of a new multimodal corridor "Turkey – Caucasus – Central Asia – South Asia through Afghanistan" and organising an annual interregional forum Uzbekistan-Azerbaijan-Turkey.

Uzbekistan's team wins 44th World Chess Olympiad 2022

In the final round of the World Chess Olympiad, Uzbekistan defeated the Netherlands in the final round and became the winner of the tournament for the first time in its history.

Increased military cooperation between Uzbekistan and Tajikistan

On the 5th of August countries held joint military exercises on the border with Afghanistan, while on the 9th of August Tajikistan's Minister of Defense Colonel General Sherali Mirzo arrived in Tashkent to meet with Uzbekistan's Minister of Defense Lieutenant General Bahodir Kurbanov. An agreement was signed by the two ministers to organise the training of Tajik military personnel at Uzbek institutions.

New economic stimulus to support businesses in Uzbekistan announced

During the Open Dialogue between the President and Entrepreneurs held from 17-22 of August in Tashkent, new initiatives, benefits and economic preferences to support businesses were announced in Uzbekistan:

- new classification for SME introducing depending on volume of revenues (currently on number of employees) with additional tax benefits;
- VAT tax reducing from 15% to 12% as of January 1st, 2023;
- property rights protection improvement with taking off from the city administration the rights of cancelling of the construction permission rights;
- de-criminalizing the violations in trade rules;
- a 3-year moratorium on introduction of new sanctions against entrepreneurs, the entrepreneur will not be punished for his mistake for 6 months;
- the Chamber of Commerce and Industry to be completely removed from the subordination of the Government.

Ministry of Finance to develop software and a mobile app for digitising the accounting of expenses related to business trip

The app will allow for employees of state-owned organisations to book seats in more than 900 hotels, conclude contracts and pay for actually used seats Learn more

Civil servants banned from accepting gifts

The President signed a new law regulating the activities of civil servants in Uzbekistan, passed by the parliament a few weeks earlier.

The President of Uzbekistan provides additional benefits to Karakalpakstan

During his visit to Karakalpakstan on the 26th of August, Shavkat Mirziyoyev gave clear instructions to officials of ministries and departments to provide additional benefits in Karakalpakstan such as:

- Profit tax rate to be reduced from 15% to 7.5% in Karakalpakstan;
- the turnover tax rate to be reduced from 4% to 2% in Nukus;
- a project to reduce land tax rates by a factor of two has been submitted for consideration;
- 200 billion sum has been allocated for family entrepreneurship programmes in addition to the already planned SUM 650 billion.

The President has instructed to form a pool of competent cadres for leadership positions in districts and cities. They will be selected only from among the aides to hokims and youth leaders in the mahallas. Shavkat Mirziyoyev also set a task to launch the "100 Progressive Leaders" programme within three months.

Uzbekistan took part in the US-organised regional US Congress delegation visited Uzbekistan military exercises in Tajikistan

"Regional Cooperation 2022" military exercises that took place from 10 to 20 August 2022 in Dushanbe, Tajikistan, included a six-day command post exercises with participants from the United States, Tajikistan, Kazakhstan, Kyrgyzstan, Mongolia, Pakistan, and Uzbekistan, and a five-day bilateral field training with U.S. and Tajik forces. Uzbekistan represented at major US textile conference

On the 6th of August, Uzbekistan participated in the Traceability and Sustainability 2022 Conference organised by the American Apparel and Footwear Association (AAFA) in Pittsburgh, Pennsylvania. During the meetings and negotiations American brands expressed interest in building partnerships with local manufacturers, as well as participation in the 5th International Textile and Fashion Industry Exhibition "UzTextileExpo Autumn 2022" to be held in Tashkent from 12-14 October. On August 21, a delegation of the US Congress, members of the Caucus on Uzbekistan, arrived in Uzbekistan to discuss the current state of bilateral relations and prospects for strengthening Uzbek-American cooperation, expanding inter-parliamentary ties. The Congressmen Trent Kelly and Darin LaHood met with President Shavkat Mirziyoyev and Acting Minister of Foreign Affairs of Uzbekistan Vladimir Norov. The sides reached an agreement on the organisation of business missions from the indicated regions of the United States to Uzbekistan.

USD 131mln to Uzbekistan via Switzerland to return the special UN fund to be allocated into social projects



On 16 August 2022 in Bern, an agreement "On ways to return illegally acquired assets for the benefit of the people of Uzbekistan" provides for the immediate return by Switzerland of USD 131 million to Uzbekistan, previously "illegally acquired by an organised criminal group led by Gulnara Karimova and legalised on Swiss territory". The

Intergovernmental consultations were held on financial and technical cooperation between **Uzbekistan and Germany**

Delegations from Uzbekistan and Germany, headed respectively by the Ministry of Investment and Foreign Trade and the Federal Ministry for Economic Cooperation and Development of Germany, held intergovernmental consultations on financial and technical cooperation on 5 August 2022. Parties discussed ongoing and promising projects totaling 350 million euros while the preparation of a promising list of projects, which will be considered during negotiations between the governments of the two countries scheduled for the end of the year.

agreement establishes a mechanism for asset restitution: openness, civil society participation, and the use of funds for health care. Restitution will be conducted through the Uzbekistan Vision 2030 multi-partner trust fund, established by Uzbekistan and Switzerland in February, but only at a cost of USD 132 million.

GmbH". Following the trip of the Ferghana delegation eight investment and export contracts and agreements worth a total of USD238.9 million were signed.

OSCE/ODIHR NAM recommends sending a mission to observe the constitutional referendum in Uzbekistan

As a result of the OSCE/ODIHR Needs Assessment Mission (NAM) to Uzbekistan from 19 to 21 July, a Needs Assessment Mission Report was issued. The ODIHR NAM recommended that a Limited Referendum Observation Mission (LROM) be sent to observe the constitutional referendum. In addition, ODIHR recommends that 14 longterm observers from OSCE participating States be seconded to observe the referendum process throughout the country. In accordance with standard methodology, the ODIHR LEOM will include an element of media monitoring. Although the mission will visit a limited number of polling stations, no systematic observation of the voting process is envisaged.








Fig.5 Total cases up to August 29 the 2022 (historical data)
