
## Uzbekistan's FTT dropped by \$5.5 billion in 2020

### The President has signed the law moving Election Day from December to October

On February 8, 2021, President Shavkat Mirziyoyev signed the law "On amendments and additions to some legislative acts of Uzbekistan in connection with the improvement of electoral legislation". The presidential election will be held on October 24 this year.

According to the document, from March 1 of this year for citizens of Uzbekistan and stateless persons permanently residing in the republic, a tourist (hotel) tax is introduced for each day of their stay in accommodation facilities.



## Uzbekistan extends privileges for tourism service providers until December 31

In accordance with the presidential decree, the following privileges and preferences have been extended until December 31, 2021:

- o reduction of the rate of profits tax for tour operators, travel agents, as well as accommodation facilities by 50%;
- partial subsidization of tour operators' air and rail ticket expenses by 30% of the ticket price for foreign tourist groups of at least 10 people, provided that they stay at least five nights;

From 2023, the excise tax on mobile services will be canceled. In 2022, the rate is expected to be reduced to 10%. In 2021, it was reduced from 20% to 15%.
