
Uzbekistan scored 2.12 points, climbed 2 lines compared to 2019, but remained on the list of countries with an "authoritarian regime".



The European Bank for Reconstruction and Development's (EBRD) new Regional Economic Prospects report forecasts a 6.5% increase in the country's GDP for 2021.


South Korea accelerates the process of concluding a Free Trade Agreement (FTA) with Uzbekistan

Changes in the taxation system for 2021

- VAT remains at 15% rate. Alcohol retailers and markets were added to the list of mandatory VAT users;
- Import excise taxes cancelled on 73 types of products, including household technics, etc.;
- Excise tax for cellular operators decrease from 20 to 15%;
- Excise tax for sugar at 20% rate;
- Excises on alcohol, tobacco, gasoline, natural gas, polyethylene increase by 10-25%;
- Planned introduction of 10% excise on cement clinker;
- Sales tax for real estate agents decrease from 25% to 13%;
- Water use and some types of property tax indexed by 15%;
- Subsoil tax for Navoi Mining and Almalyk Mining (AGMK) for precious metals and copper productions set at 15%;
- Mandatory annual revaluation (indexation) of fixed assets is cancelled for all types of entities (huge step toward harmonization of local standards to IFRS).
