2. Once the Exhibitor's display and/or vehicle are set up in the show, they shall not be removed or concealed by the Exhibitor prior to the end of the show without the permission of the Producer.
3. Neither the Producer, the sponsor, nor any officer, director or shareholder, thereof, or the owner of the building at which the show is produced, shall be responsible or liable for any loss or damage to all or part of the Exhibitor's personal property, which shall specifically include, but not limited to, the Exhibitor's vehicle, trailer, display, material and/or parts, and the Exhibitor's hereby waives any and all rights it may have against them or any of them for such loss or damage. Exhibitor agrees to obtain insurance covering the above and assumes full responsibility for any loss or damage.

Exhibitor agrees that this signed entry blank supersedes any and all prior and/or contemporaneous agreements and understandings whether written or oral between Exhibitor and the Producer, its Producer's employees, show staff, representatives and sub-contractors. Nothing herein shall be modified unless consented to by Producer in writing. Both parties agree all disagreements will be decided by arbitration in the state where the show is produced. All parties will hold harmless and indemnify Sound Management, LLC., its employees, officers and representatives.

4. No commercial advertising is allowed with entries unless they are appearing in conjunction with paid commercial space. A single sign may be used to identify major modifications, who did them and what equipment was used, but large ad signs, handbills or business card distribution is prohibited.
5. In consideration of this entry, the owner and spouse and guests agree to permit the Producer or its assigns the use of their name and pictures and pictures of the entered vehicle for publicity, advertising and commercial purposes (including newspapers, magazines, radio and television) before, during and after the event, and do hereby relinquish any rights whatsoever to any photos taken in connection with the event, and give permission to publish or sell or otherwise dispose of said photographs to the Producer or its assigns. All publicity and advertising rights reserved by the Producer or its assigns.

SCHEDULE

The building will open for setup the Friday before the show and will close that evening. The regular show hours are 10AM to 7PM Saturday and 10AM-5PM Sunday, (September 12th & 13th)

FRIDAY SETUP

Cars will be set up by appointment only. Please contact entry@southbendautoshow.com to arrange your setup time. You must be setup before 9PM Friday, September 10th unless prior arrangements have been made. If you arrive early, cars will wait in parking lot until scheduled time to keep things moving efficiently. Trailers can be offloaded in parking lot, however must be moved to another location after the vehicle has been removed.

GROUPS

If you plan on displaying vehicles in a group you must submit applications for each vehicle together 30 days prior to the show date. Group requests received after September 10th will not be considered for group placement. Full effort will be made to accommodate all group placement requests received on time, however no guarantees can be made.

SAFETY

All vehicles must have a quarter or less tank of fuel, the battery disconnected and gas cap locked or taped off in some fashion. Also, please provide a drop cloth, paper, cardboard for underneath your vehicle in case of any type of leaks.

JUDGING

Judging will take place on Saturday from 10AM - 6PM. Any questions about final judgements and awards can be asked after the show award ceremony. Award ceremony will be held on Sunday, starting at 4PM.

PASSES
