Historical background


Ashe County, located in the Appalachian mountains of North Carolina's northwest corner, is about 427 square miles in area. Its current population is just over 27,000.1 Ashe has never been heavily settled and its population did not exceed 10,000 until after 1870.2

The area was originally a part of Anson County in the early colonial period and was inhabited by Native Americans. In 1753, the area was designated a part of Rowan County, then in 1771, a part of Surry and then of Wilkes in 1777. It was considered a part of the State of Franklin from



1784-1789. Ashe as a county was officially created from Wilkes County 18 November 1799. At that time Ashe stretched from the western border of Wilkes to the Tennessee line. In 1848, Watauga County was established from the south-western part of Ashe and in 1859, Alleghany County was carved out of the northeastern corner.³

Bishop Augustus Spangenburg, looking for land for a Moravian settlement in 1752, was the first recorded European to visit the area.⁴ There are records of hunting expeditions beginning around 1770, with Daniel

Boone's being the most well-known.⁵ Some documents pertaining to people living in what is now Ashe County from 1771-1777, may be found in Surry County records and for the period from 1777-1799, in Wilkes. For these periods, a check of all three may be needed.

The Ashe county seat is Jefferson. Other communities in Ashe include: West Jefferson, Creston, Clifton, Lansing, Fleetwood (formerly Bowie), Glendale Springs, Helton, Todd (formerly Elkland), Warrensville, Grassy Creek, North Fork, Laurel, Fig, Oldfields, Pine Swamp, Walnut Hill, Horse Creek, Peak Creek, Piney Creek, Pond Mountain, Shatley Springs, Hurricane and Obids.

Birth and Death records

Births

Official birth certificates began to be issued in Ashe County in 1913. Ashe County births from 1946-1998 are available in online indexes at *FamilySearch* and *Ancestry*. Official birth records from before this time must be found elsewhere. Ashe County birth certificates dating back to 1913 may be found at NC Vital Records and at the Ashe County Register of Deeds Office which maintains a searchable database available on site, but not online.

Cemetery Records

Records for virtually all of the still extant and legible Ashe County grave may be found online at *FindaGrave*. (http://www.findagrave.com) Many Ashe family cemeteries are in remote, hilltop locations. An effort has been made in recent years to update the cemetery locations given on *FindaGrave* to make them easier to find (This author was a part of that effort). The Ashe County Register of Deeds Office has mapped the exact location of many Ashe cemeteries. Their data is available when visiting in person at their office. Of visiting Ashe cemeteries, dress for hiking and be prepared to climb over (or under) fences and up steep hillsides. While many cemeteries are well cared for, be prepared for those that are not. You may want to pack clippers for overgrown sites, long pants and sleeves for briars and poison ivy.

Russell Hamilton's 2 volume *Ashe County Cemetery Records* (see list of published sources above) covers burials from about 1800 to mid-20th century. This comprehensive set is arranged alphabetically by surname of deceased. Information is taken from grave markers and obituaries for all known Ashe County cemeteries. Also includes locations for each cemetery (note: some directions are outdated as roads and landmarks may have changed. Check another source if in doubt). Available at ACPL, GHL (GHL Call #929.3 N8as H216a) or for purchase from <u>Ashe County Historical Society</u>. These volumes contain records not found elsewhere because markers are missing, destroyed or worn beyond legibility.
