The Rainbow Splash Pad saw lots of use this summer thanks to the hot weather. The Committee would like to thank those volunteers who came out to help us raise funds by working an evening Bingo in Winnipeg. We were awarded this Bingo through the Manitoba Community Services Council. Our hard work earned us \$3,000.00 so it was well worth the effort. Although these funds were initially targeted to pay for the 2nd water cannon, this plan has been

changed. The Committee met with Village Council to discuss concerns regarding hours of operation and notification of closure of the park.

Some changes have now been made in this regard to make hours and availability more user friendly. Due to the possible changes in accessibility of water for the park and concerns voided by the Village in regards to costs, it was decided by the Committee to redirect these funds. Consideration is being given to purchasing

more picnic tables and park benches and setting them on concrete slabs to make mowing easier. Another possibility is interlocking brick for the stepping stone pathway.

The Splash Pad painters were hard at work again this year repairing some of the stepping stones that have deteriorated. We are doing our very best to maintain them and although we have made many phone calls and inquiries to cement companies and paint companies, there seems to be no solution to our problem of stones flaking. A BIG THANK YOU goes out to those painters who again donated their time to help repair the stones.

Growing Our Funds ----

2005 marked the launch of a Scholarship and Bursary Building Incentive Program by the Province of Manitoba. This half-million dollar matching funds program, administered by the Winnipeg Foundation, recognizes the additional costs of relocating that rural students experience as they pursue post-secondary education.

How fortunate we were to be able to access the program! Through this initiative, the NNMF Community Education Fund was increased by \$4,286.48, the NNMF Haley Steward Fund was increased by \$7,960.62, the NNMF MacGregor Emergency Fund was increased by \$3,372.24 and the NNMF Rumancik Memorial Scholarship Fund increased by \$3,061.77. Our contribution of \$30,507.00 was matched based n a 61.24% ratio and our added portion was the biggest in the province thanks to our generous donors.

The program is available until 2010. Some families have put their this year's donations into named scholarships and others have added funds to the Foundation's Community Education Fund.

Alf and Allison Graham Memorial Bursary will be awarded to a well rounded graduating student demonstrating excellent academic performance and significant school and community involvement. Application is made to MCI with one reference letter.

Rumancik Memorial Scholarship goes to a graduating student who has achieved a high overall academic average in a grade 12 program which includes two English credits.

All above awards includes "to a student who faces the additional financial burden of relocating in order to pursue his or her academic studies".

There is still time to get into the matching program for this year with the deadline set for January 31, 2007. If you would like to contribute to education of young people, this window of opportunity to have your dollars matched is open. If you have questions, contact any Board member.



What's New? Leadership Program

The NNMF is exploring the possibility of initiating a "Youth in Philanthropy" program. Representatives from the Community Foundation of Portage and District (CFPD) met with our Foundation and the principals of the local schools to explain the program.

Portage partnered with the Thomas Sill Foundation in a six-year program 2002 - 2007 where the TSF funded the program at \$3,500 per year per high school for the first three years and CFPD provides the funding and continues the program for the next three years. The intent of the program is to provide leadership development for participants. It is designed to give a deeper understanding of community volunteerism and public service. Young people become involved in philanthropy.

Guidelines are provided to help the school design the structure for a Youth Advisory Council (YAC). The Council develops a list of values, researches charitable organizations and selects the charities they would consider for grants. In pairs, the YAC members make presentations to the chosen charities and ask how they could be of help. Decisions are made by the YAC after presentations are made by the returning pairs. YAC recommendations are made to the CFPD Boards and the grants are presented (\$500 maximum).

If a decision is made to pursue the program, application will be made to the Thomas Sill Foundation for partnership. In the first three years NNMF will accept donations toward the continuation of the program from people interested in the concept.

A Message from the North Norfolk-MacGregor Healthy Communities Committee

Did you know that the main focus of the Healthy Communities Committee is not just "Health"?

The Healthy Community Committee is working with churches, schools, Inter-ridge recreation, service groups and other community stakeholders to make North Norfolk and MacGregor a better place to live.

The Committee has developed or supported such initiatives as the Progressive Agriculture Safety Day and Safe Kids week. A "Kids in the Kitchen" program, promoting healthy eating and meal preparation was very successful. Early literacy programs such as the START program targets preschoolers and their parents. An integrated community emergency assistance program is under development.

Recently community members and fourth year Health Studies students from Brandon University worked together on a Community needs assessment. As a result of those findings a *youth risk survey* was conducted with over 400 responses from eight public and private schools in the municipality of North Norfolk. A youth sub group was formed with representation from education, seniors, health, recreation and Youth for Christ. The next step will be to analyze the data and to hold youth focus groups.



--- Austin Hall Building Fund Update -----

New Rules For Charitable Donations

Retirees are among the most generous people in Canada when it comes to making charitable donations, but it's best to plan your giving to maximize the tax benefits. And some new rules introduced this past summer make certain types of donations more attractive than ever before.

Any charitable donations up to \$200 you make in a

given year are credited at the bottom marginal rate about 20 per cent, depending on the province. Any additional amounts, however, are credited at the top marginal rate, up to 50 percent, depending on your province.

As a result, while the generally recommended strategy would be to contribute before each yearend to get the tax breaks

as soon as possible, you may want to hold off claiming your credit and claim two or more years' donations in a single year instead. That way, you increase the amount eligible for the higher credit rate.

You can carry charitable donation credits forward as long as five years. This is particularly beneficial if you are in the habit of donating relatively small amounts under \$1,000 or so. Say, for example, that you are in the habit of giving \$500 a year to charity. Each year you would get a tax credit equal to about \$40 on the first \$200, and as much as \$150 on the remaining \$300, for a total credit of \$190 each year.

Now say you were to give \$1,000 every other year instead.

You would get the same \$40 on the first \$200, and up to \$400 on the remainder, for a total of \$440 over two years. That's \$60 more than if you got those credits of \$190 each year $(2 \times $190 = $380)$.

As for that rule change, in the past you were allowed to give investments directly to charity, rather than selling them and then giving cash. You still had to pay capital gains tax on this "deemed disposition," but at

only half the normal rate. Since only half of your capital gains are normally taxable anyway, you would have to include only one-quarter of the gain in your income for the year.

So if, for example, you gave securities that had grown in value by \$1,000 and your marginal tax rate were in the 30 per cent range, you normally would pay \$150 in tax (30 per cent of \$500); if you gave the securities to charity instead, you'd have to pay only \$75.

Under new rules introduced this past summer, however, if you give securities as a gift to charity, you don't have to pay any tax at all on the gain. This strategy can be a very cost - as well as tax - effective way to donate.

"This rule doesn't apply just to stocks," says Warren Baldwin, vice-president of T.E. Wealth in Toronto. "It also applies to mutual fund

units, or just about anything that attracts capital gains tax. It's a wonderful way to give, but if you intend to do this, you should get on it right away.

"For starters, "Baldwin explains, "you need some time to figure out exactly what you're going to give. You have to contact the charity and get the necessary documentation in order, and the transfer itself can take a few days. So don't wait until the last minute, or you might miss the year-end."

As for what you should give, Baldwin advises that you give whatever assets have accrued the largest gain. "You might have some U.S. or foreign mutual funds that have gone up a little bit, and some Canadian funds that have gone up a lot. So give the Canadian funds, because that will give you the biggest tax savings."

Finally, if you've blown all your cash on Christmas, don't fret; you can still donate by charging it on your credit card. Provided you pay off the loan within the grace period - typically 20 to 30 days - you won't have to pay any interest charges.

The best advice - consult your chartered accountant.

In past years the Kinette and Kinsmen Clubs have had lights on their "Kin Tree". This year the Kinettes decided to undertake lighting up the Kinette Gazebo located in the Fred Coates Memorial Park and also adding additional lights to the park located east of the MCC store on MacGregor's Main Street. To date we have received funding support from MacGregor North Norfolk Foundation and the MacGregor Chamber of Commerce. Beautification Efforts Continue

The beautification of downtown MacGregor was greatly enhanced by the creation of a community park adjacent to the new Co-op Farm and Building Supply. Portage la Prairie Consumers Cooperative Limited had the vision to purchase and develop the property. They worked with the village, Kinettes, the Community in Bloom committee and Prairie Blossom to make the park a reality. The park was dedicated to the memory of Fred Coates, Branch Manager 1983 - 2003.

The Coop's partnering and commitment to our community was noted and commended by the C.B. judges in their report.
