#### Letter to the Editor Addressed to Channel 7—ABC News

#### **RE: Lido Beach Renourishment**

After watching the Thursday and Saturday evening ABC 7 news stories about the Lido Beach renourishment, I am very concerned that only one side of the story is being told: the side of the Siesta Key residents and boaters who do not want the renourishment to occur.

ABC 7 reported on the Thursday evening meeting on Siesta Key and the Saturday morning meeting at the Sarasota Yacht Club, but there was no report at all about the meeting on Lido Key on Friday morning. That meeting was organized by the Lido Key Residents Association and was held at the Helmsley Hotel. Despite the media being invited, no media representatives were present. Had you attended, you would have heard a presentation by the Army Corp of Engineers and the City of Sarasota Engineer who have worked on this project explaining why it is needed, what would be done, and that it will have minimal if any impact on Siesta Key Beach or boaters.

Your story about the meeting at the Yacht Club stated that the media asked to attend but were not permitted to come inside, somehow implying that information was being kept from the public. The only person interviewed on camera was someone complaining about the project. Why wasn't there also an interview with someone who supports the project? Better yet, why not interview one of the Army Corp of Engineers representatives who gave a presentation at the meeting and who could have explained for the TV audience the entire project, why it is needed, and why the fears being hyped are unfounded.

Had you attended the Lido Key meeting you would have been welcomed inside and you would have learned that over the past few years tons of sand have washed off of Lido Beach and into Big Pass. Only a small portion of this Lido sand will be removed from the Pass for the initial renourishment, and an even smaller amount removed in future years (again from sand that will have washed off of Lido in the intervening period.) Siesta Key Beach was fine before this sand accumulated in the pass and will be fine when it is removed. There is minimal if any danger to Siesta Beach, which is actually quite far away from the sandbar. Across the pass from the South end of Lido are houses with seawalls - not a beach.

Your stories have not given any information to the public about why this project is so desperately needed. Have you walked down Lido Beach at high tide? If you did, you would see that there are several areas that are severely and dangerously eroded. One condo building near the South end of Lido is in danger of being undermined. At high tide, the waves wash up against a seawall only a few feet from a first floor condo. Why is a picture of the waves crashing in front of that condo not a part of the story? Why are there no facts reported about the project? Why is the story only what people say they fear? Why aren't these people questioned to find out if there is a reasonable basis for their fear?

Since when is someone saying, without any stated rationale, that they are afraid something will happen a news story? That would be like me saying that Dolphin Towers should not be repaired because I am afraid it will fall over while the work is being done and I will be hurt. Is my fear something to report on the news? Is that a basis not to repair Dolphin Towers? I think not.

So, I ask you to please contact the City of Sarasota Engineer or the Army Corp of Engineers personnel who have worked on this project now for several years. Interview them. Find out the facts. Then report the facts, not the baseless fears. Your audience deserves no less.

## **Letter to the Editor** Addressed to the Herald Tribune **RE: Coverage of Lido Key Association's Concerns**

Although requested, Eric Ernst did not attended the Lido Key Residents' Association meeting Saturday, December 6, 2013. Nor did any Herald Tribune staff attend. Responsible reporting mandates coverage of the Lido Beach Association concerns on beach replenishment after two articles appeared in the Herald Tribune on December 2 December 6 covering Siesta Key Beach Association's concerns.

Fear does not create reality. Erosion occurs primarily from north to south. Beach replenishment will need to be continuously done. According to the Army Corps of Engineers, using groins plus replenishment will extend the process from 2-2.5 years to 5 years. Big Sarasota Pass shoal continues to enlarge and by using less than 3% of that sand for replenishment should have minimal environmental impact. This sand primarily comes and will continue to come from Lido beach. No action will be environmentally and economically disastrous for the Lido public beach, hotels, condominiums, and businesses especially in the St. Armand's Circle area.

Please report Lido beach community concerns in the future. Thank you for your consideration.
