#### Sarasota County Park Update Post Hurricanes

Nicole Rissler, Director of Parks, Recreation and Natural Resources stated in a November 14th email that," currently South Lido Park remains closed. It had significant impacts from both hurricane Helene and hurricane Milton with lots of debris being pushed up into the natural area. We have contractors working to clear debris from the parking lot and around the park as well as in the natural area.

Please note that the Ted Sperling, nature Park and kayak launch area has been reopened to the public. I will touch base with staff on timing for reopening the beach portion, but I do believe it will still be a couple weeks out."

I received an email from The Florida Department of Health in Sarasota County (DOH-Sarasota) that stated they, "issued a health alert for the presence of red tide near Ringling Causeway/Bird Key Park, North Lido Beach, Lido Casino Beach, Siesta Key Beach, Nokomis Beach, North Jetty Beach, Venice Beach, Service Club Beach, Venice Fishing Pier, Brohard Park Beach, and Manasota Key Beach. This is in response to a water sample taken on November 12, 2024." At Lido Key red tide was reported on Nov 12th at concentrations less than 1,000 - 10,000 cells per liter. This is considered "very low".

DOH-Sarasota advises residents and visitors to look for informational signage posted at most public beaches and/or check current water quality status at <u>water-quality-status-dashboard</u>.

Sarasota County Hurricane Milton Debris Collection Report stated that as of November 12th since October 13th a total of 1,119,070 cubic yards of debris had been collected. Of that 1,119,070, 1,006,810 cubic yards were vegetative debris. These totals do not include debris collected in the cities of Sarasota, Longboat Key, Venice, and North Port.

It is an understatement to say we've had an historic year. Four natural disasters within four months! The massive rain event in June which caused creeks and rivers to flood proper0es that had never experienced flooding. Then, of course, there was Debby, Helene, and Milton. As residents of a barrier island, you know better than anyone how devastating these events were. My heart goes out to all of you who suffered and are s0ll suffering with your loss.

As I am writing this, there is another potential hurricane on the horizon. I can only hope it will stay far away

from here. Also, as I am writing this, we are still in the process of cleaning up the debris caused by these hurricanes. The initial estimate is that it would take 12,000 truckloads to clear it all. We have 40 trucks working seven days a week to remove the debris as quickly and efficiently as possible. Our goal is to complete the process within 90 days.

As you know, there was also an election this year. I was re-elected for a third term as your City Commissioner from District 2. I am very grateful for your support and your faith in me and I will work hard to earn your continued support.

#### What to do with all of the sand?

Guidelines on how to remove sand left behind by Hurric is collected and whether it's on private property or a pull Department of Environmental Protection regulations to beach, in part because the sand could contain nails, debr

#### What can you do with sand from your property?

State guidelines allow for clean sand collected from a posimply returned to the beach above the mean high water be disposed of by a contractor.

The city of Sarasota has separate sand clearing guideline customers – the latter of which also includes condominiums and hotels. "The big question we've been receiving from residents is what can we do with the sand," city of Sarasota spokeswoman Jan Thornburg said. "The good news is we anticipate a lot of it will meet FDEP guidelines and we'll be allowed to return it," to the beach.

Residential customers can place sand at the right-of-way in front of their property, while ensuring that the sidewalks and roads are not obstructed.

#### Red tide alert issued for Sarasota County beaches

A red tide alert has been issued for several Sarasota County beaches.

The Florida Department of Health in Sarasota County has issued a health alert for the presence of red tide near Ringling Causeway/ Bird Key Park Beach, North Lido Beach, Lido Casino Beach, Siesta Key Beach, Turtle Beach, Nokomis Beach, North Jetty Beach, Venice Beach, Service Club Beach, Venice Fishing Pier, Brohard Park Beach and Manasota Key Beach.

This is in response to a water sample taken on Nov. 12. The public is advised to exercise caution in and around this area. Guidance includes:

Do not wade or swim in or around red tide, which can cause skin irritation, rashes, and burning/sore eyes.

Remain cautious and stay away from red tide locations, especially if suffering from chronic respiratory conditions.

Residents of beach areas are advised to close windows and operate air conditioners. Make sure the air conditioner filter is maintained according to manufacturer's specifications.

Do not harvest or eat shellfish or distressed or dead fish from these areas.

Keep pets away and out of the water.

#### Mote Marine Hurricane Milton Update

Mote Marine Laboratory and Aquarium (Mote) faced an unprecedented challenge on the region, just days after Hurricane Helene had already caused significant occasion, showcasing commitment to aquatic life and conservation amid their storms.

During recovery and stabilization efforts from the impacts of Hurricane Heler and protective measures in advance of the arrival of Hurricane Milton, which many of their neighbors in the community, were already dealing with their or homes from Hurricanes Helene and Debby, and the fear of devastation of thei incoming Hurricane Milton. Yet Mote staff displayed an unwavering dedication being of the animals in our care in both pre-storm preparations and swift, cod research laboratories and animal care facilities.

With limited time, and resources already stretched thin by impacts of Hurrica

made to successfully relocate two manatees to a partner facility out of the direct forecasted path of the hurricane and transport endangered sea turtles, alligators, birds, river otters, as well as other key species, to Mote Aquaculture Research Park 13 miles inland. These efforts were made possible through the tireless work of Mote's expert staff with support from numerous partners. Staff worked around the clock to ensure laboratories and animal care facilities were secure, animals were as safe as possible, and emergency severe weather protocols were followed. Their success was evident in the survival of the overwhelming majority of diverse marine and coastal animals in Mote's care. However, as with any environmental catastrophe of this scale, not all outcomes were as hoped.

In the face of this disaster, a heartbreaking loss occurred with two beloved North American river otters, Huck and Iane, tragically passing away during the hurricane. Despite every effort to ensure their safety, including medical intervention, the unprecedented nature of the back-to-back hurricanes and the resulting stress presented health issues that unfortunately could not be overcome. The loss of these otters is deeply felt, not only by Mote staff, but by the broader community as well. For years, these otters have been more than just residents at Mote — they were beloved ambassadors of our mission, teaching visitors of all ages about the importance of freshwater coastal ecosystems and conservation. Their playful antics, intelligence, and charm made them instant favorites, bringing joy and inspiration to aquarium guests. Their loss is a reminder of the severity of the storm's impact, but it also strengthens the Mote family's resolve to protect and care for the animals who continue to thrive under our watch.

"Mote's legacy of science-based marine conservation and highest quality animal care continues to thrive, thanks to the dedication of our staff, volunteers and trustees, along with the unvielding support of the broader community," said Dr. Michael P. Crosby, Mote President & CEO. "While we face difficult days ahead, alongside our equally resilient and recovering community, we will emerge from this crisis stronger with a renewed commitment to our vital mission of restoring and conserving our shared marine and coastal ecosystems through excellence in research and translation of our science to enable a more ocean literate public."
