#### City of Sarasota Considering Ordinance to Regulate Some Single Use Plastic Items on Public Property

According to Keep Sarasota County Beautiful data, 52,733 plastic and polystyrene (commonly known as StyrofoamTM) pieces were found on our County beaches during cleanups from 2013 to 2017. These pieces enter our waterways and break into small pieces, called microplastics, resulting in negative impacts on our wildlife. In addition to educational campaigns and efforts to encourage community members and businesses to voluntarily transition away from single-use plastics, the Sarasota City Commission is considering an ordinance on July 15 that would prevent food service establishments operating on public property from distributing or using polystyrene materials. It would also require food service establishments operating on public land to only provide single use straws if specifically requested by the customer. The goal is to help encourage the reduction and reliance on single use plastic materials. The City understands that single-use products can be necessary for many community members, especially those living with disability, to meet basic needs or live independently. It is the intent of this policy to raise awareness of the often-unnecessary distribution of disposable items and to reduce local plastic pollution in our waterways. Even during the summer in the city, Sarasota's Lido Key continues to be one of the most interesting geographies on the Gulf Coast. At its center is the unique, John Ringling inspired, St. Armand's circle. Beautifully landscaped, filled with quality shops, dining establishments and dotted with Ringling sculptures, it is one of America's most unique business districts.

Just a mile away one can transition from the commercial world and enter the world of nature and the deep blue sea. Head north from St. Armand's Circle and in minutes you will be to City Island and Ken Thompson Park, which has been the longtime home to the Mote Marine Science Laboratory and aquarium.

Founded in 1955, Mote was recruited to City Island by Sarasota's leaders in 1978 and is now one of 130 marine laboratories in the United States. Mote has evolved to become one of America's leading, independent marine laboratories, by combining marine science research, with public education and public outreach. 200,000 visitors per year continue to visit Mote's modest aquarium where over 100 marine species are on display. The Mote science campus employs over 200 including over 30 PhD's and is supported by over 1,000 dedicated volunteers.

As one of America's leading research institutions studying red tide, ocean acidification and coral reef restoration, Mote's presence has benefitted our community and area wildlife in many ways and all one has to do to see examples is to circle back from Motes campus, to Lido Beach.

Lido beach is especially interesting this time of year. Walking north on Lido Beach from the pavilion area one can observe the increasing number of sea turtle nests which have been marked for protection with sticks and orange screening by Mote volunteers. This ongoing effort is helping preserve the logger-head sea turtle population. The public is very supportive of the effort to protect the sea turtle nesting areas as the eggs prepare to hatch each fall as Sarasotans root for the thousands of sea turtle hatchlings to return to the Gulf and survive.

Even more interesting are the sea bird nesting areas on Lido that are cordoned off by Mote and the Audubon Society volunteers to protect the sea bird nesting areas. Lido has one of the largest concentrations of Black Skimmers in the state. This threatened species, with their long wing spans, orange webbed feet, and orange and black bills, miraculously skim the water's surface, bills open, for food. Between rest and skimming they often put on daring, Blue Angel quality air shows with synchronized, rapid climbs, dives and swoops above the water's edge, teaching their youth to frolic as they fly. It is a fun, inspiring and fascinating scene. It may be summer in the city but some of Satasota's best nature shows are now underway, and they remain free to this day.

#### **MOTE MARINE VIRUAL REALITY PODS**

Those looking to swim alongside humpback whales or head into outer space now have the chance with the addition of virtual reality pods at Mote Marine Laboratory & Aquarium.

Now nestled in the aquarium's exploration gallery, the pods ask users to put on a virtual reality headset and sit in an automated chair. The user is then transported to an alternate reality of their choosing.

"It's just an opportunity to expose our guests to a new type of technology," said Stephannie Kettle, Mote public relations manager. "Swimming with humpbacks is not something that we can showcase here at our aquarium, so it's the best way to see them."

The aquarium, which got the pods from Immotion, a United Kingdom-based company, offers nine experiences. Two of the nine feature live-shot film, while the others feature computer-generated images.

Visitors can swim through a shipwreck in the Bahamas, fly with a dragon or ride a ghost train. Each experience lasts four to five minutes and costs \$6.


While there are nine experiences now, Evan Barniskis, assistant vice president of the aquarium, said Immotion is creating new experiences.

"As soon as they're developed, we will get new experiences to offer," he said. "Just because people come now to experience the pods, if they come back in six months, there may be a whole new set of different experiences for them."

In fact, Immotion crews recently finished filming a shark experience in the Bahamas, and plan to add two more subsea CGI experiences. Barniskis said he also hopes to work with Immotion to create a video about the aquarium in the future.

Kettle said the aquarium is using the pods as an opportunity to experiment with interactive technology so that when the aquarium expands, it can offer more virtual experiences to its guests.

The pods are now open to the public from 10 a.m. to 4:30 p.m. daily.

#### Speed hump project beginning July 15 in St. Armands

This process was supposed to start on July 8 but was postponed because of bad weather.

Last year, the Florida Department of Transportation agreed to implement the speed humps after a coordinated push from the city of Sarasota and the St. Armands Circle Association. Brian R. Rick, communications specialist at FDOT, said the city and the association came to FDOT with the problem of cars going too fast in the circle.

A statement from FDOT said to expect nighttime/overnight lane closures from 10 p.m. to 6 a.m. once work is underway.

FDOT plans on studying the effects of the speed humps, which mimic elevated pedestrian crosswalks in how they slow motorists. If raised crosswalks are deemed viable once the speed humps are removed, FDOT hopes to eventually install raised crosswalks, though such a project would take time and require funding, Rick said.

"At the end of a year they [the speed humps] will be removed and the intent is to have a raised pedestrian crosswalk and raised intersections within and adjacent to the circle," Rick said. "Now a raised crosswalk also facilitates the same objective, which is to get vehicles to slow down."

A release from FDOT focused on the safety aspect of the speed humps.

"These speed humps are designed to encourage motorists to slow down when driving through the circle, enabling pedestrians to safely cross the road and reducing the number and severity of crashes," the release read. "Unlike speed bumps that are often seen in large apartment complexes, speed humps provide a gentle transition and traffic calming environment, which can reduce speeds from 15 to 20 mph."

Diana Corrigan, executive director of the St. Armands Circle association, said three pedestrians have been hit in her 20 years in the area, "And that's three too many," she said.

The speed humps are made of recycled synthetic rubber. At \$40,000 the project costs roughly \$5,000 per speed hump. FDOT is paying for the project.
