### Beach Update (Paul/Jay)

Siesta Key lawsuit in civil court gave the city 20 days to show why they should not be required to obtain approval from the Sarasota County Commission. They want the city to ask the county for permission to dredge. The federal court case could take another 60 to 90 days. However, an RFP will be going out in March for the dredging project. It is expected that at least three big companies will bid. We are continuing to move forward.

Chris Ziegler, the county commissioner for district 2 again stated that it has been the county commission's position that they would not get involved in the civil suit.

### **Pool Pavilion**

The city commission will discuss the renegotiation of the pavilion at a meeting on February 19<sup>th</sup>. This item is last on the agenda and should be heard between 3:00 and 4:30.
