# Sandy Gilbert - START (Solutions to Avoid Red Tide)

Sandy presented a power point addressing the following:

- The causes of red tide: Red tide is always around. It is heightened by water temperatures from 59-85, salinity of 31%-34% and bright sunlight.
- Why it is so bad here:
   Two of the largest nutrient dumps, the Mississippi River and Lake Okeechobee, are affecting our shoreline.
- What's being done:
   START is working to educate people, promote state legislation that reduces the nutrients in our waterways, work with local government to upgrade aging infrastructure, increase natural nutrient control, and find solutions to filter storm water before it goes into the bay
- What YOU can do:
   We can all help by cleaning up ponds, fertilizing responsibly, keeping leaves and grasses
   out of stormwater drains, using less water, minimizing runoff from your yard, and
   disposing of kitchen and bathroom waste responsibility and limiting electrical use.
